PROPOSED BMPs	<p>Best Management Practices</p> <p>Rosetta Resources Operating LP proposes to utilize the following Best Management Practices (BMP's) where appropriate, to prevent or reduce impacts caused by our oil and gas operations:</p> <ul style="list-style-type: none"> <li>• When building new well sites, limit the surface area to be disturbed to just that which is needed. When a new well is drilled and put on production, reclaim the unneeded well pad to reduce the disturbed surface area and allow the landowners to use it for agriculture.</li> <li>• Return the land to near pre -use condition by reforming the surface to match the surrounding area including: terracing, drainage replacement/repair, and re- seeding with native grasses as specified by the Soil Conservation Office.</li> <li>• Spray to control noxious weeds on our locations annually.</li> <li>• Inspect our sites for erosion and install erosion controls such as culverts or find an alternate road route that is less likely to erode.</li> <li>• As much as possible, utilize low impact 2 tracks on lease roads.</li> <li>• Fill drill site pits within 120 days after completion of a new well subject to pit moisture and weather.</li> <li>• Hydrocarbon storage tanks are surrounded by impermeable berms to prevent spills from migrating off -site.</li> <li>• Open top tanks and unattended pits that might contain hydrocarbon are fenced and covered with nets to protect migratory fowl and animals.</li> <li>• Plans are in place to prevent, control, and cleanup hydrocarbon spills.</li> </ul>
