SPECIAL WARRANTY DEED

TO HAVE AND TO HOLD the said premises above bargained and described, with the appurtenances unto Grantee, its successors and assigns, forever. Grantor, for himself and his heirs, personal representatives, and assigns, does covenant and agree that he shall and will warrant and forever defend the above-bargained premises in the quiet and peaceable possession of Grantee, its successors and assigns, against all and every person or persons claiming the whole or any part thereof, by, through, or under Grantor.
