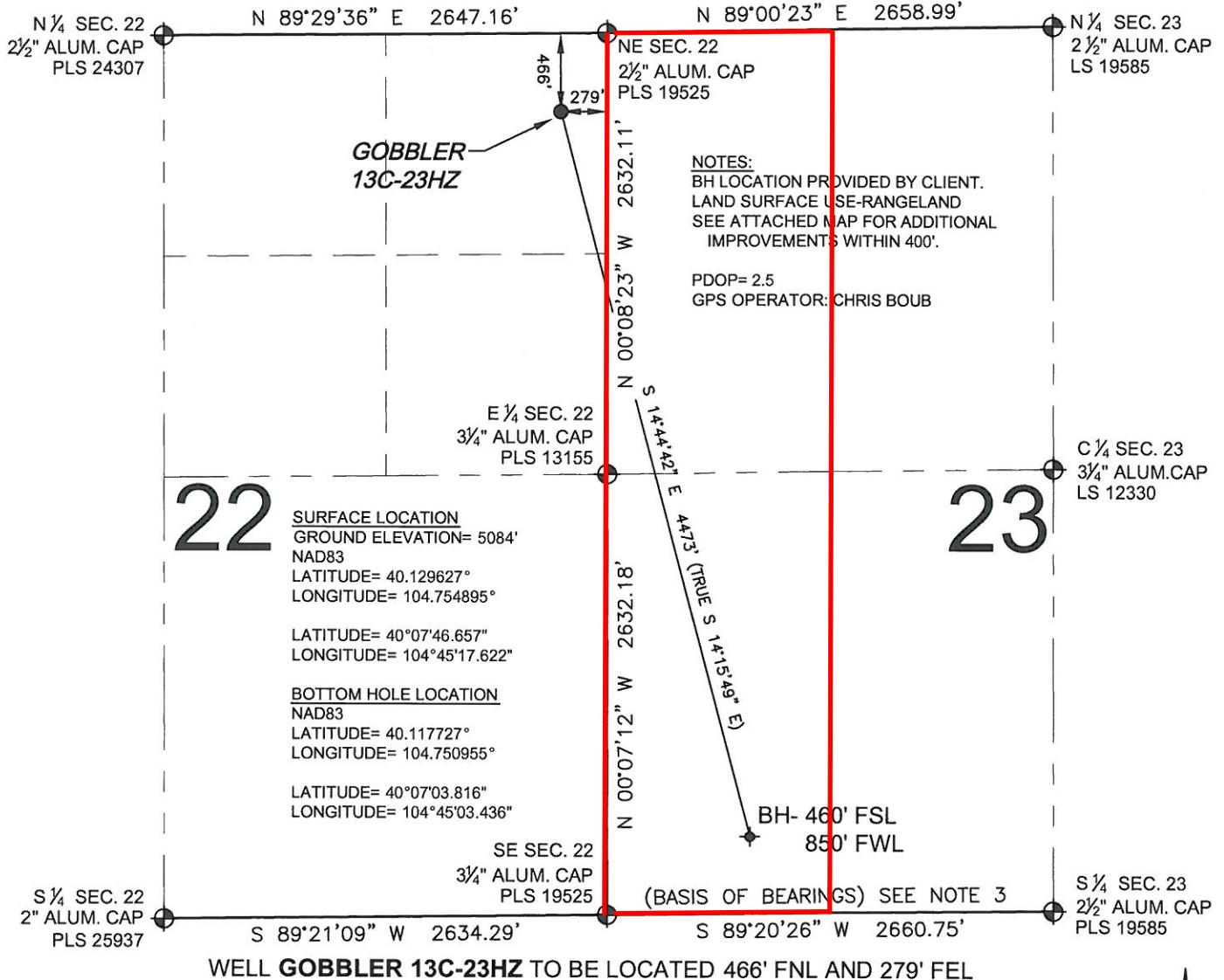

# PROPOSED SPACING UNIT MAP

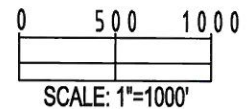
## WELL LOCATION CERTIFICATE: GOBBLER 13C-23HZ

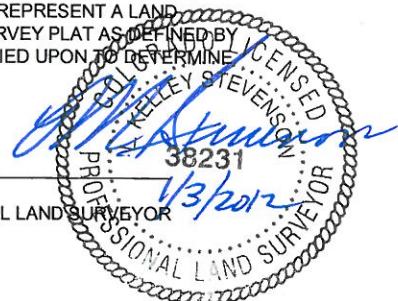
