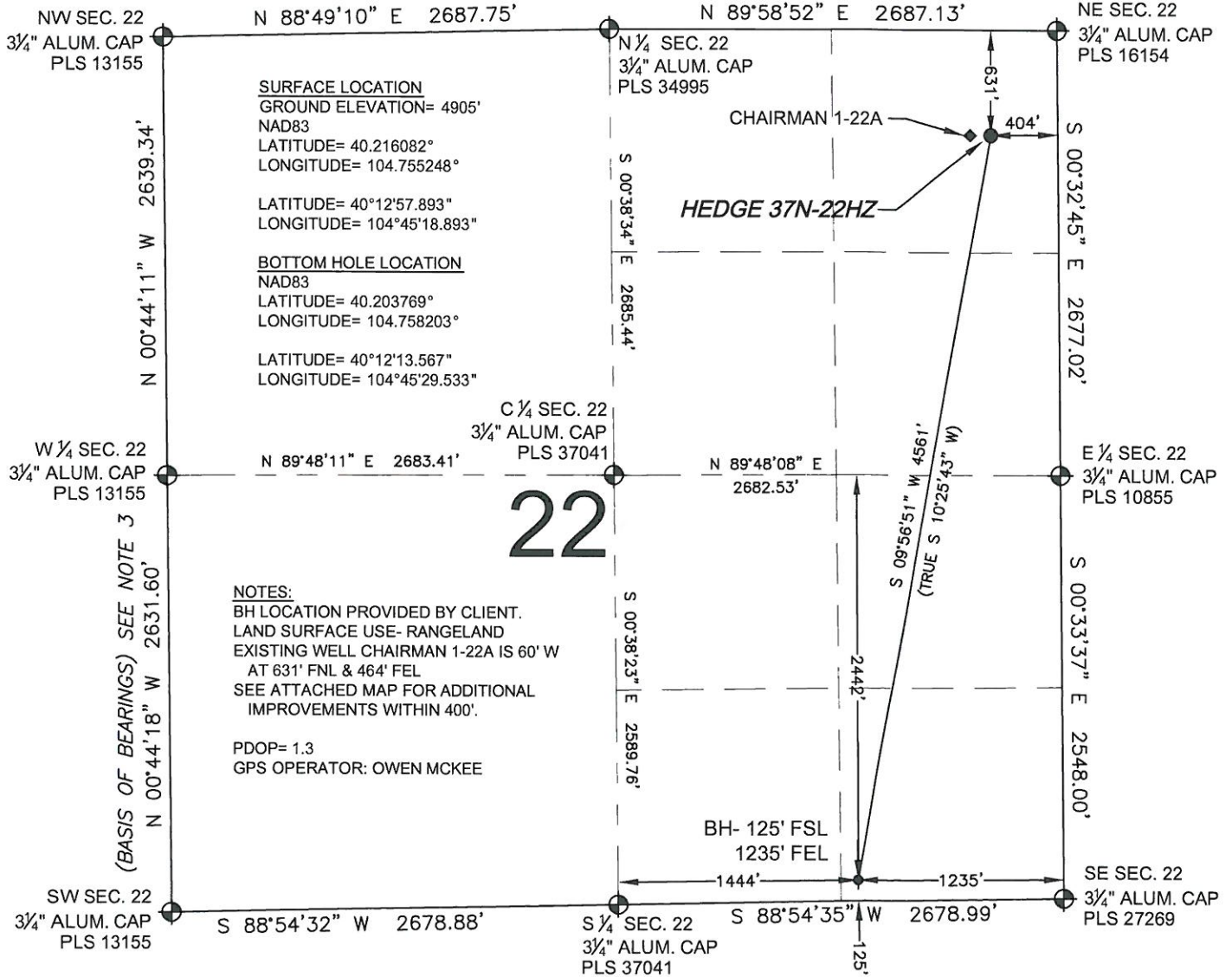


WELL LOCATION CERTIFICATE: HEDGE 37N-22HZ

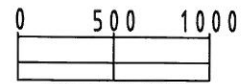
