Dear Ms. Pyeatt:

EnCana Oil & Gas (USA) Inc. ("EnCana") staked the Herren 5-2-33 and Herren 6-0-33 well at a surface location 253 feet from the north line and 294 feet from the east line of Section 33, Township 3 North, Range 67 West for the Herren 5-2-33 and 247 feet from the north line and 302 feet from the east line for the Herren 6-0-33 (see attached survey plat). This well is being drilled under the rules and regulations of the Colorado Oil and Gas Conservation Commission's ("COGCC") Rule 318A known as the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule. This rule states that all boundary infill wells be drilled from the same surface locations as previously designated in Rule 318A.a.(1) which reads:

"In the Greater Wattenberg Area ("GWA"), operators may utilize the following described surface drilling locations (GWA windows") to drill, twin, deepen, or recomplete a well (GWA well") and to commingle any or all of the Cretaceous Age formations.

- (1) A square with sides four hundred (400) feet in length, the center of which is the center of any governmental quarter-quarter section ("400' window"); ...

The Herren 5-2-33 and Herren 6-0-33 well was staked at a location 256' northeast of the defined 400' window. As this location was staked with your consent and approval, EnCana respectfully requests your consent to an exception location for the Herren 5-2-33 and 6-0-33 Wells by waiver of the COGCC Rule 318A.a (1).
