In the matter of the petition of Shell Oil Company for an order from the Colorado Oil and Gas Conservation Commission providing for twenty acre drilling and spacing units according to the governmental survey thereof for the muddy sand, often referred to as the "D" sand, common source of supply underlying the W/2 of section 16 and all of section 17 and the N/2 of section 20 and the NW/4 of section 21 all in township 8 North, range 53 West of the 6th p.m. in Logan County, Colorado, which area is presently referred to as the Luft field.

to all interested persons and to whom it may concern:

The Oil and Gas Conservation Commission of the State of Colorado, at the request of Shell Oil Company, has called a hearing to consider the promulgation of field rules to govern the location of wells in the Luft Field area, in Logan County, Colorado, so as to prevent the waste of oil and gas, either or both in said field.

All operators and owners of working interests or minerals and all persons interested in said field are hereby notified by the State of Colorado, as represented by the Oil and Gas Conservation Commission of the State of Colorado, that the above entitled matter has been set for hearing before the Commission on
