Casing repair and Remedial cementing

TIH and circulate to 6877'. TIH w/ CIBP and set @6710', dump 2 sx cmt. Pressure test casing, would not pressure-up, locate holes between 1603' and 2604', est free point @ 2850. TIH and cut casing @ 2860' and POOH. Lay down 2859.9' 4 1/2" casing. TIH w/ casing patch and new 4 1/2" casing and worked over stub. Pull 15K, pressure test to 1500 psi for 15 min, test good TIH w/ annular WS, TIH and set EOT @ 2847', pump 435 sx 12# Varicem, return 5 bbl to surface.

Run CBL from 3050 to surface

TIH and drill CIBP, push to 6871 (PBTD)
