an order from the Colorado Oil
and Gas Conservation Commis-
sion which will establish forty
acre drilling and spacing units
for the "J" sand common
source of supply underlying
the N $\frac{1}{2}$, SW $\frac{1}{4}$ and W $\frac{1}{2}$ SE $\frac{1}{4}$
of Section 26, all of Section 27,
the N $\frac{1}{2}$ of Section 34, and the
N $\frac{1}{2}$ of Section 35, all in town-
ship 8 North, Range 55 West,
Logan county, Colorado, here-
in referred to as the Bonham
pool.

To All Interested Persons and to Whom It May Concern:

The Oil and Gas Conservation Com-
mission of the State of Colorado on
the application of J. R. Howell, Jr.,
and A. P. Daniels, Shell Oil Company
and the Carter Oil Company, has
called a hearing to consider the
promulgation of field rules to gov-
ern the spacing of wells in the "J"
Sand, common source of supply un-
derlying the N $\frac{1}{2}$, SW $\frac{1}{4}$ and W $\frac{1}{2}$
SE $\frac{1}{4}$ of Section 26, all of Section
27, the N $\frac{1}{2}$ of Section 34, and the
N $\frac{1}{2}$ of Section 35, all in Township 8,
North, Range 55 West of the 6th P.
M., Logan County, Colorado, so as
to prevent the waste of oil and gas,
either or both, in said field.

spacing of wells and practices relat-
ing to the drilling and completion
of said wells in said field.
