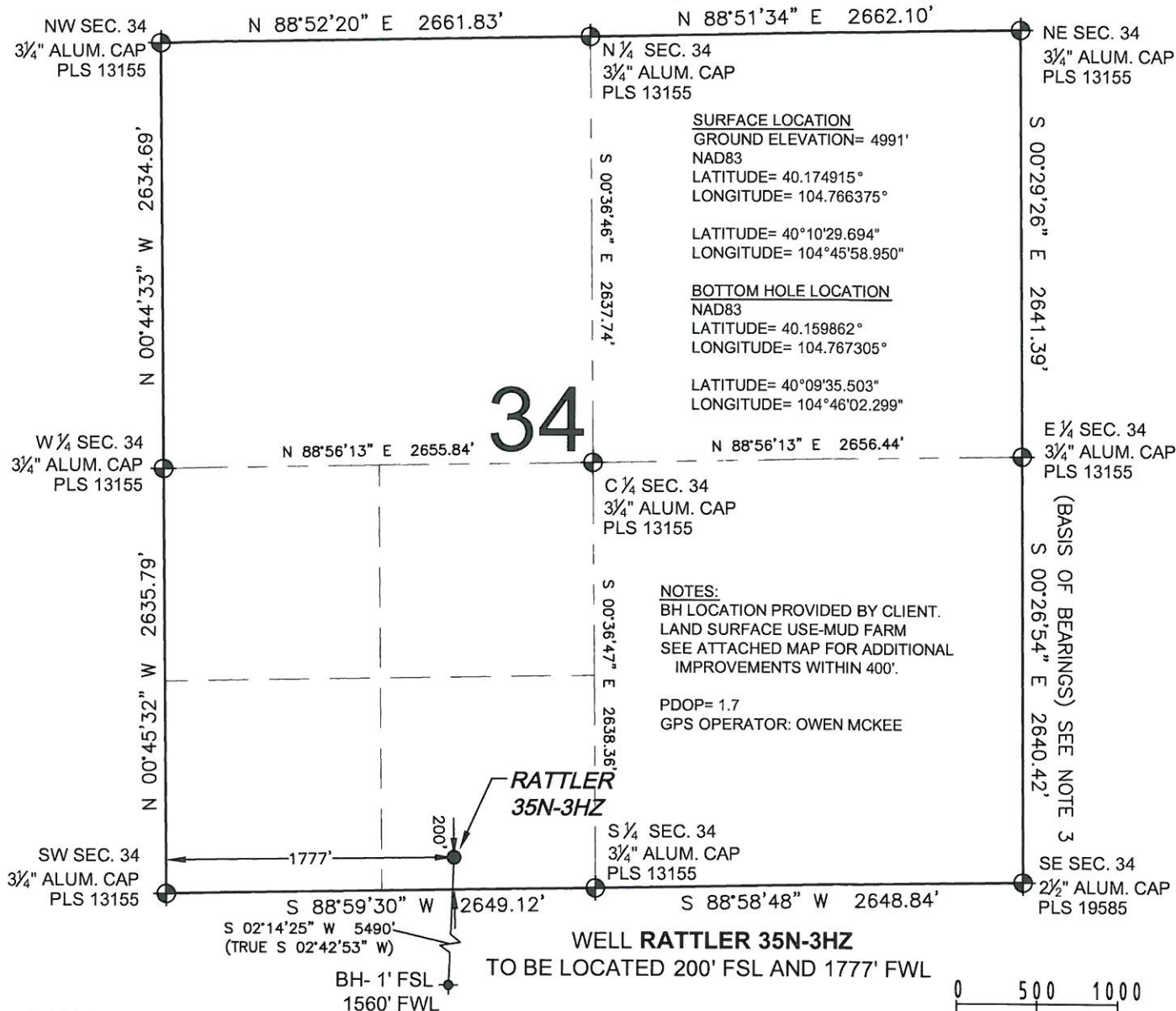


WELL LOCATION CERTIFICATE: RATTLER 35N-3HZ

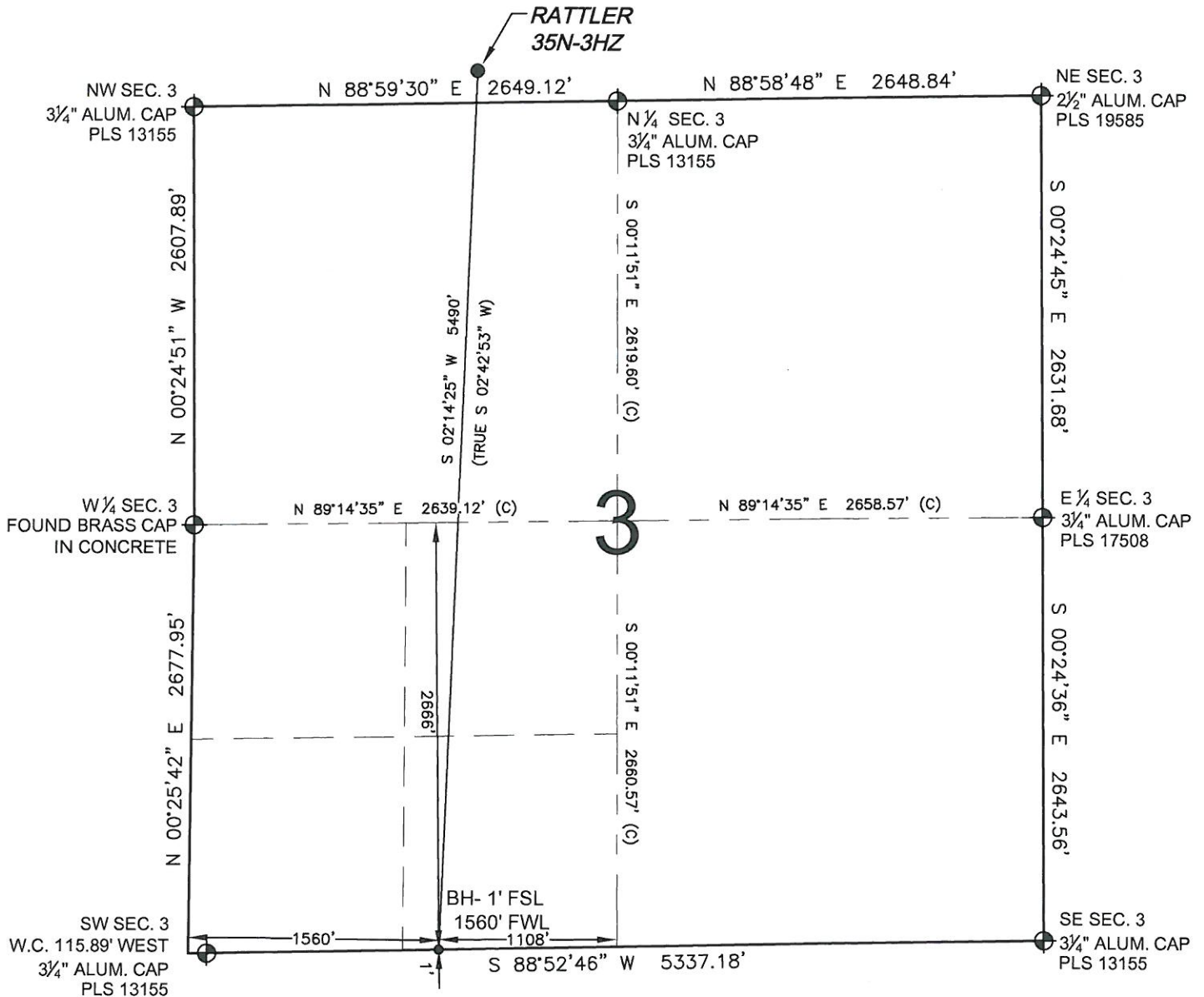

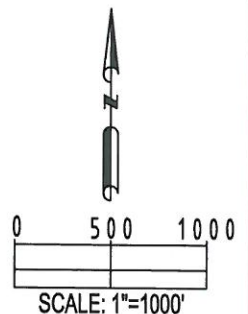
