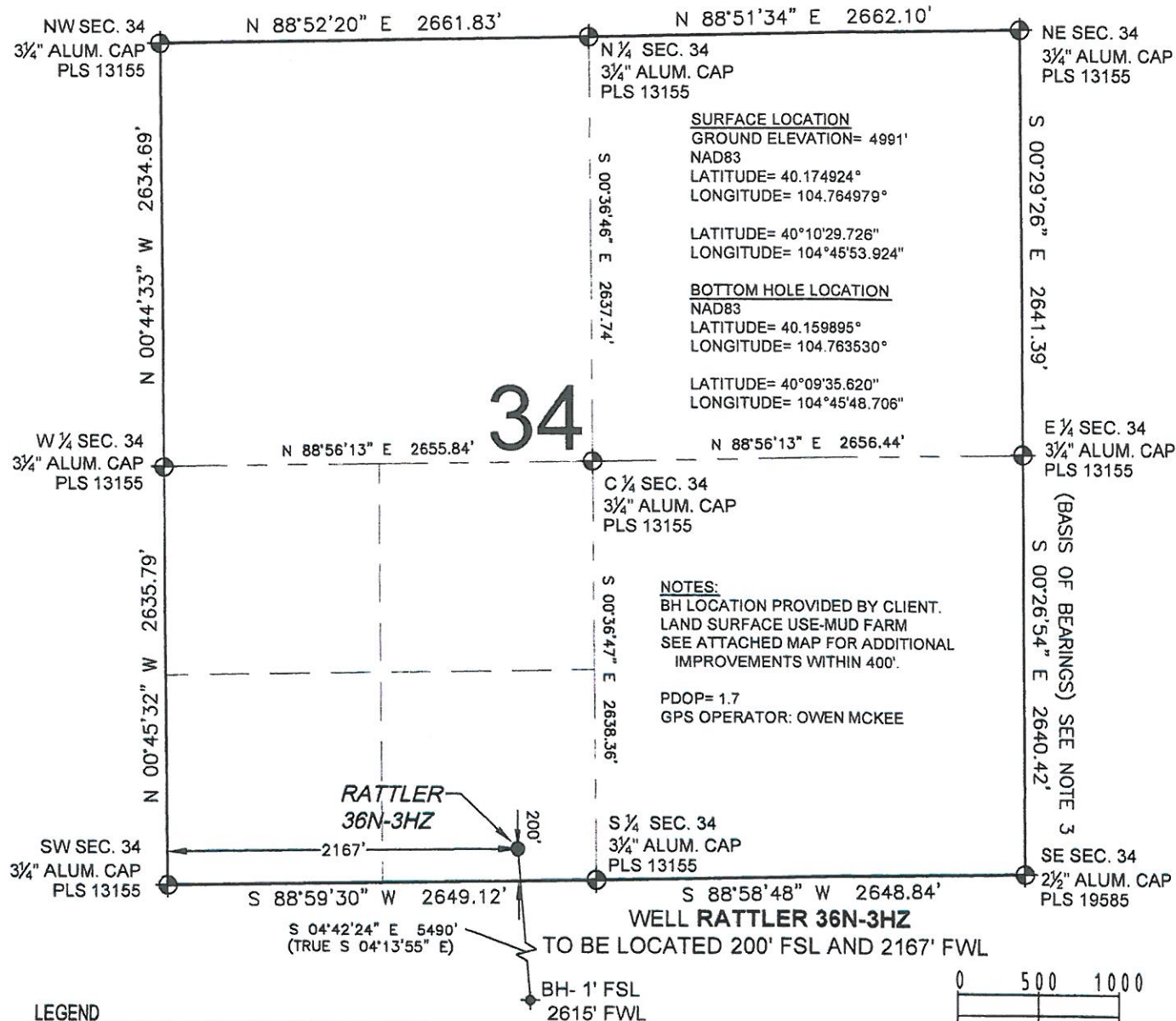


WELL LOCATION CERTIFICATE: RATTLER 36N-3HZ

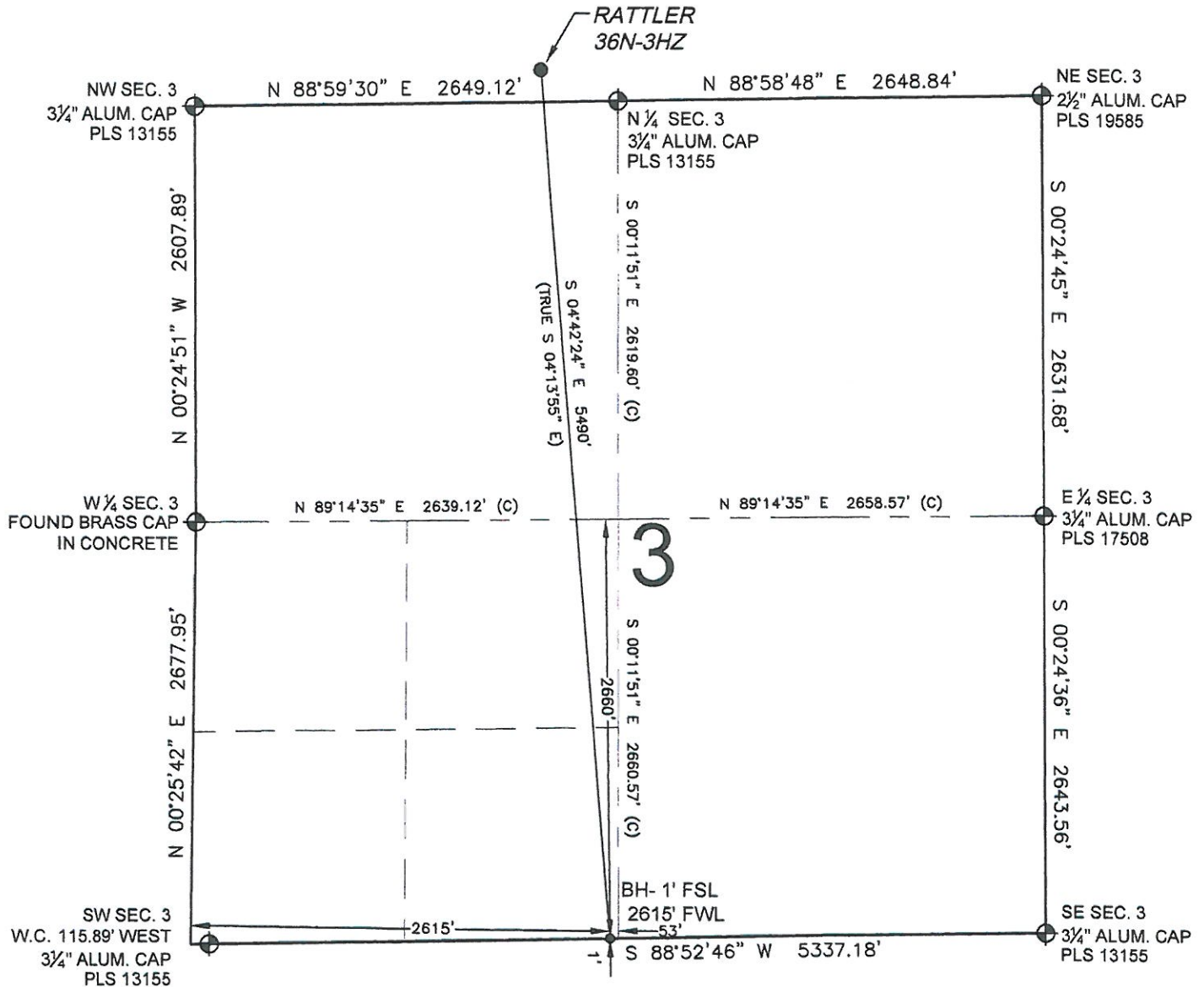
