WE HAVE HAD SEVERAL CONSULTATIONS WITH THE PROPERTY OWNER ON THE LOCATION OF THIS TANK BATTERY AND THE PROPERTY OWNER HAS AGREED UPON THIS LOCATION. A SURFACE USE AGREEMENT IS IN PROCESS.
