Planning	The Operator participates in the Colorado Oil & Gas Association Voluntary Baseline Groundwater Sampling Program.
Storm Water/Erosion Control	Stormwater management plans (SWMP) are in place to address construction, drilling and operations associated with oil and gas development throughout the State of Colorado.
