Closest Water well permit #: 202961/The surface location of this well is an exception to Rule 318A.a and to Rule 318A.c. This well is not within the GWA surface location window and does not meet the twinning requirement due to the number of wells planned for this area and at the request of the surface owner. An exception location request letter and signed waivers are attached to the Form 2 and Form 2A. Oil Base Mud will be used in the laterals over 8,000' with mud disposal offsite and a disposal facility. Shorter lateral wells will use water base drilling fluid which will be disposed of offsite by land spreading.
