COGCC has received your Form 27 Site Investigation and Remediation Plan for the above referenced location. The Form has been approved with the following conditions (COAs):

1. Provide GPS coordinates for both of the pits;
2. Provide depth and dimensions of excavations, and sample depths;
3. Provide documentation of waste disposal from pits;
4. Include detailed reclamation plan to address salt kill;
5. Per inspection resulting in violation (4/10/2012, document #667500003), include documentation of appropriate disposal or treatment of oily soil observed at battery and treater in accordance with Rule 907e; and,
6. Include documentation of concrete/debris disposal or recycling.

Note that the correct operator number for Western Operating Company is **95620**, not 7800. A copy of the approved Form 27 (document #2230511) is attached. Refer to Remediation Project #7315 and the correct operator number on future correspondence.
