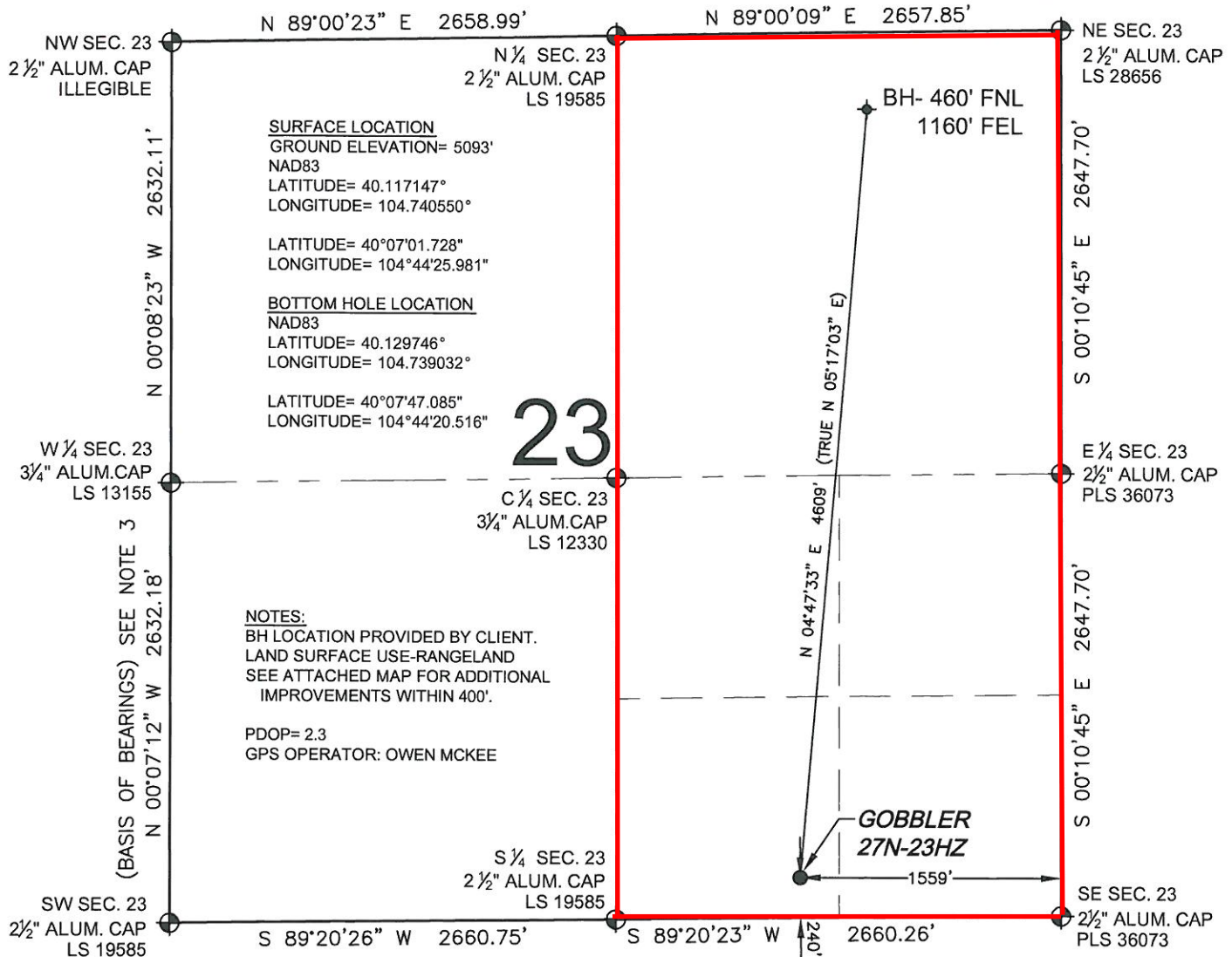

WELL LOCATION CERTIFICATE: GOBBLER 27N-23HZ

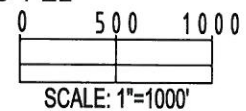

 ● = PROPOSED WELL ◆ = EXISTING WELL

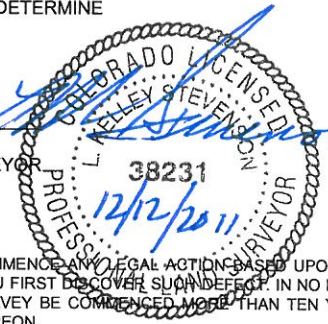
