


WELL LOCATION CERTIFICATE




In accordance with a request from Lance Harper with Continental Resources, Petroleum Field Services, LLC has determined the surface location of the LEGGETT 1-5H to be 1970' from the SOUTH line and 250' from the WEST line and the bottom hole to be 1200' from the SOUTH line and 660' from the EAST line as measured at right angles from the section line of Section 5, Township 7 North, Range 60 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 10/01/12, for and on behalf of Continental Resources, that this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
