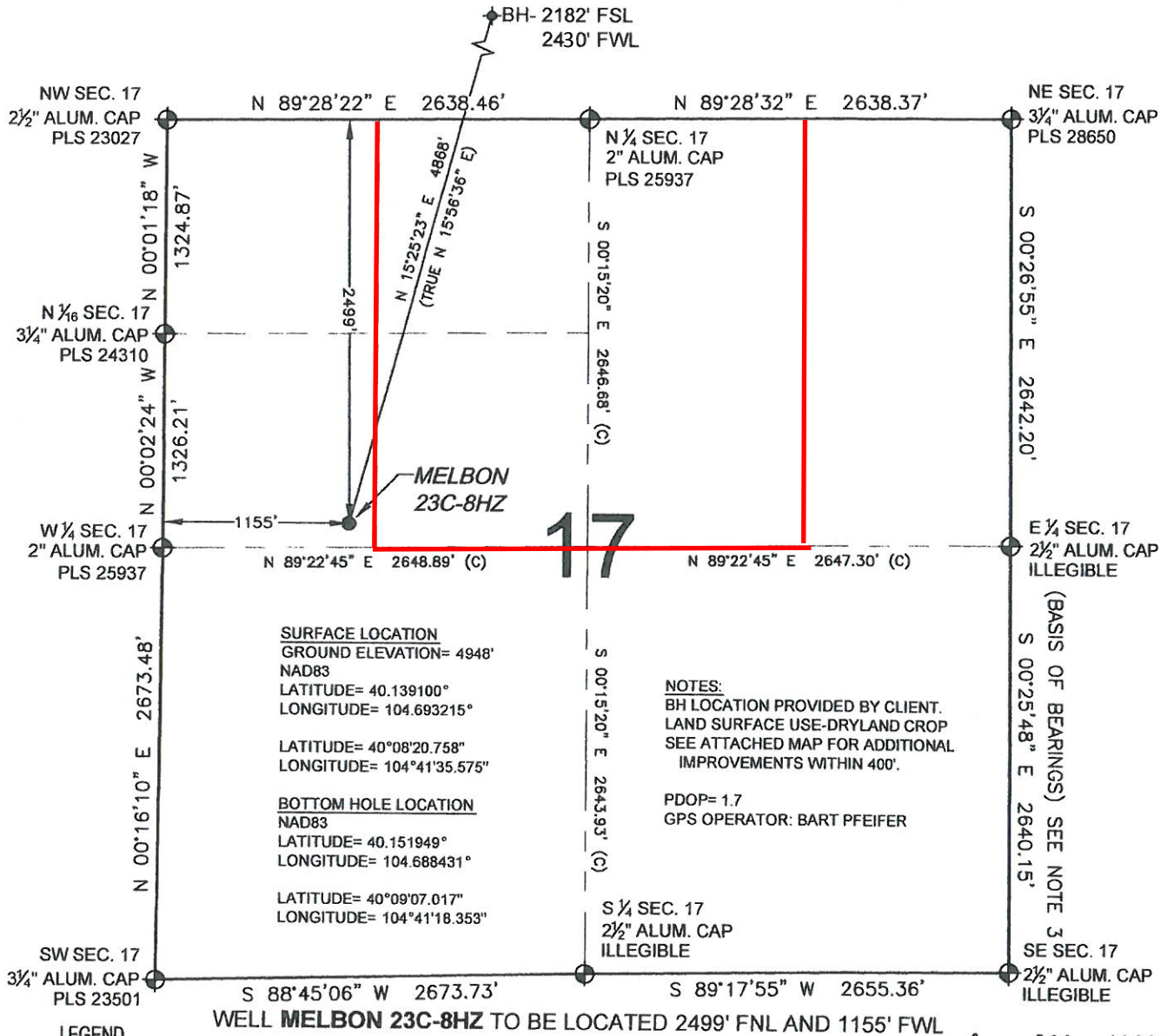

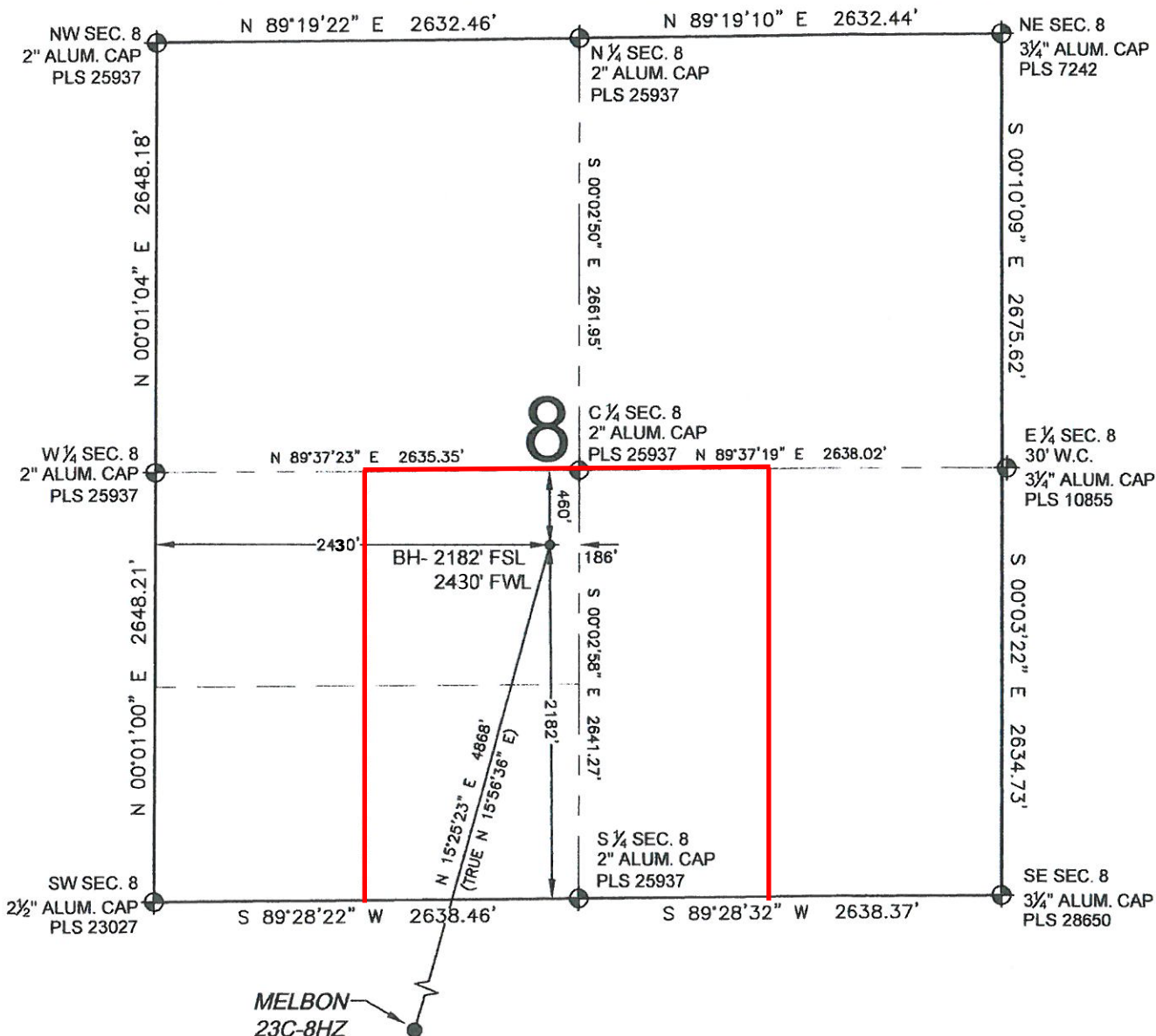

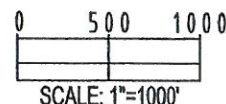
# WELL LOCATION CERTIFICATE: MELBON 23C-8HZ
