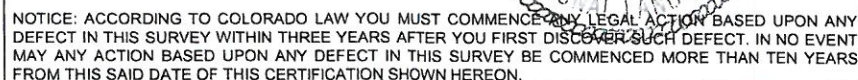

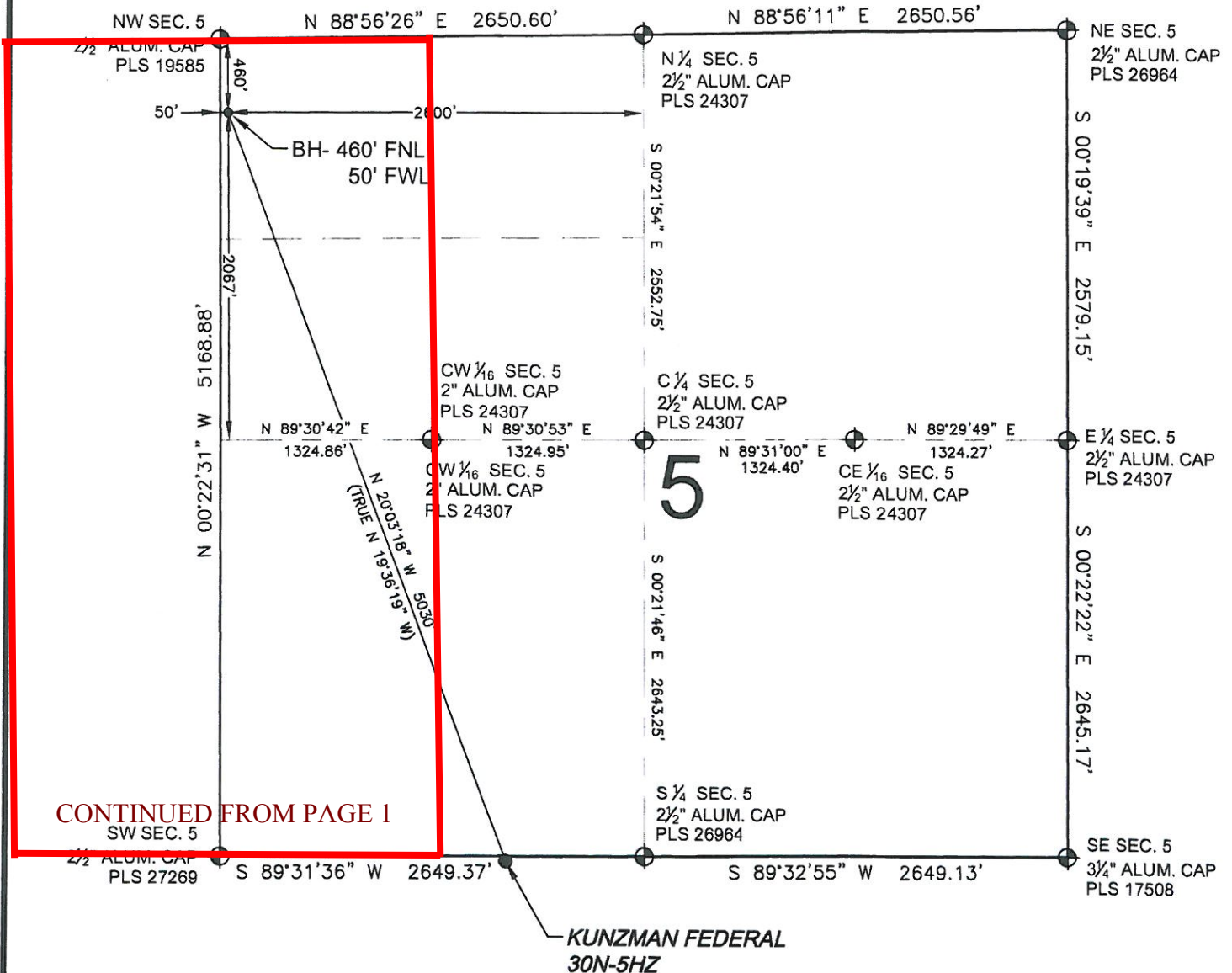

WELL LOCATION CERTIFICATE: KUNZMAN FEDERAL 30N-5HZ

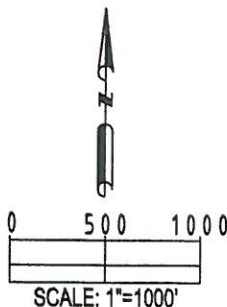
