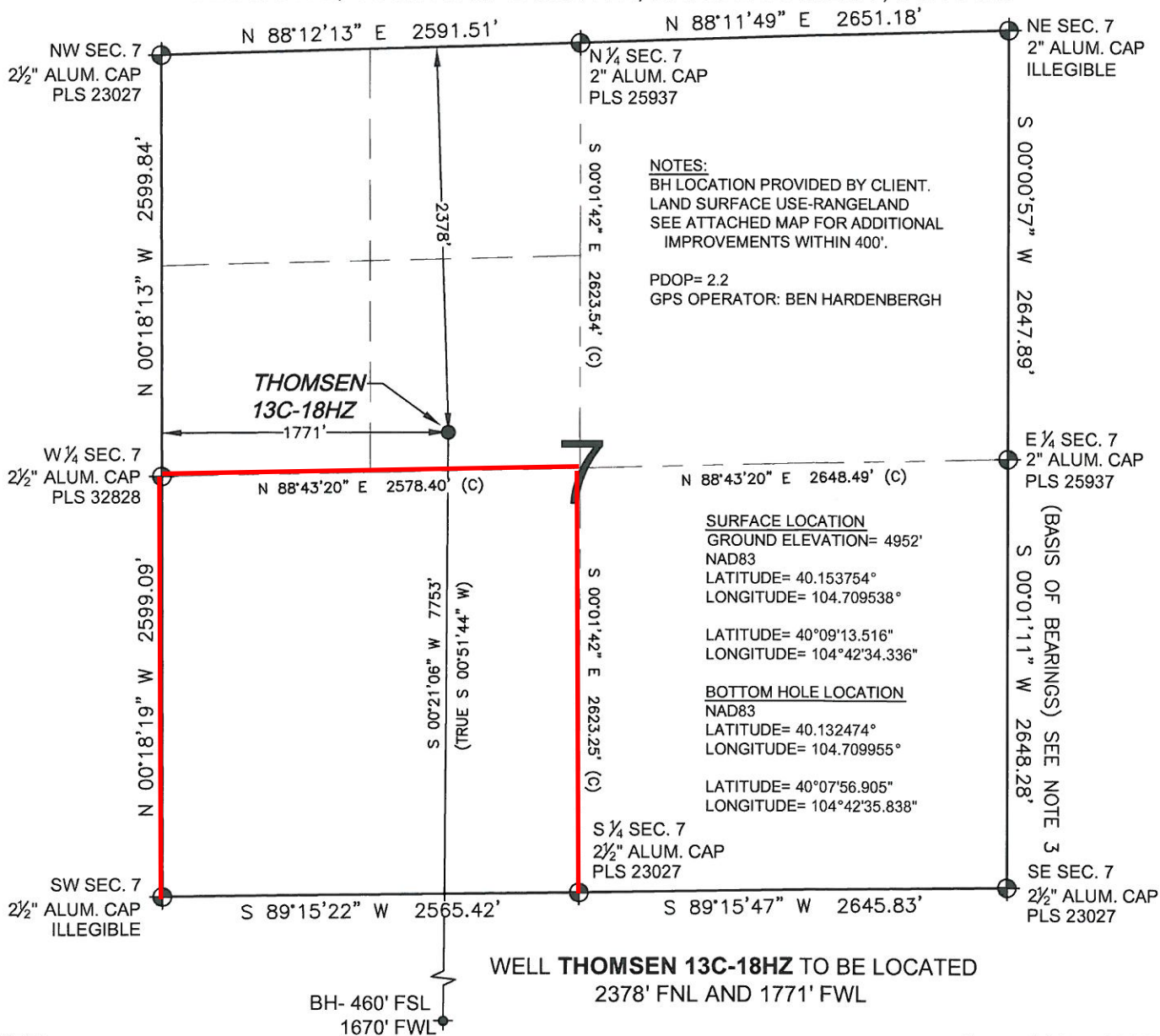

# SPACING UNIT MAP

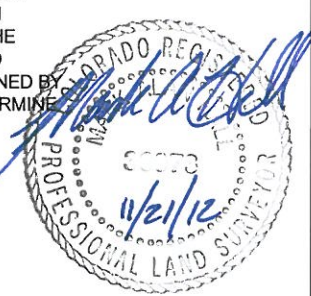

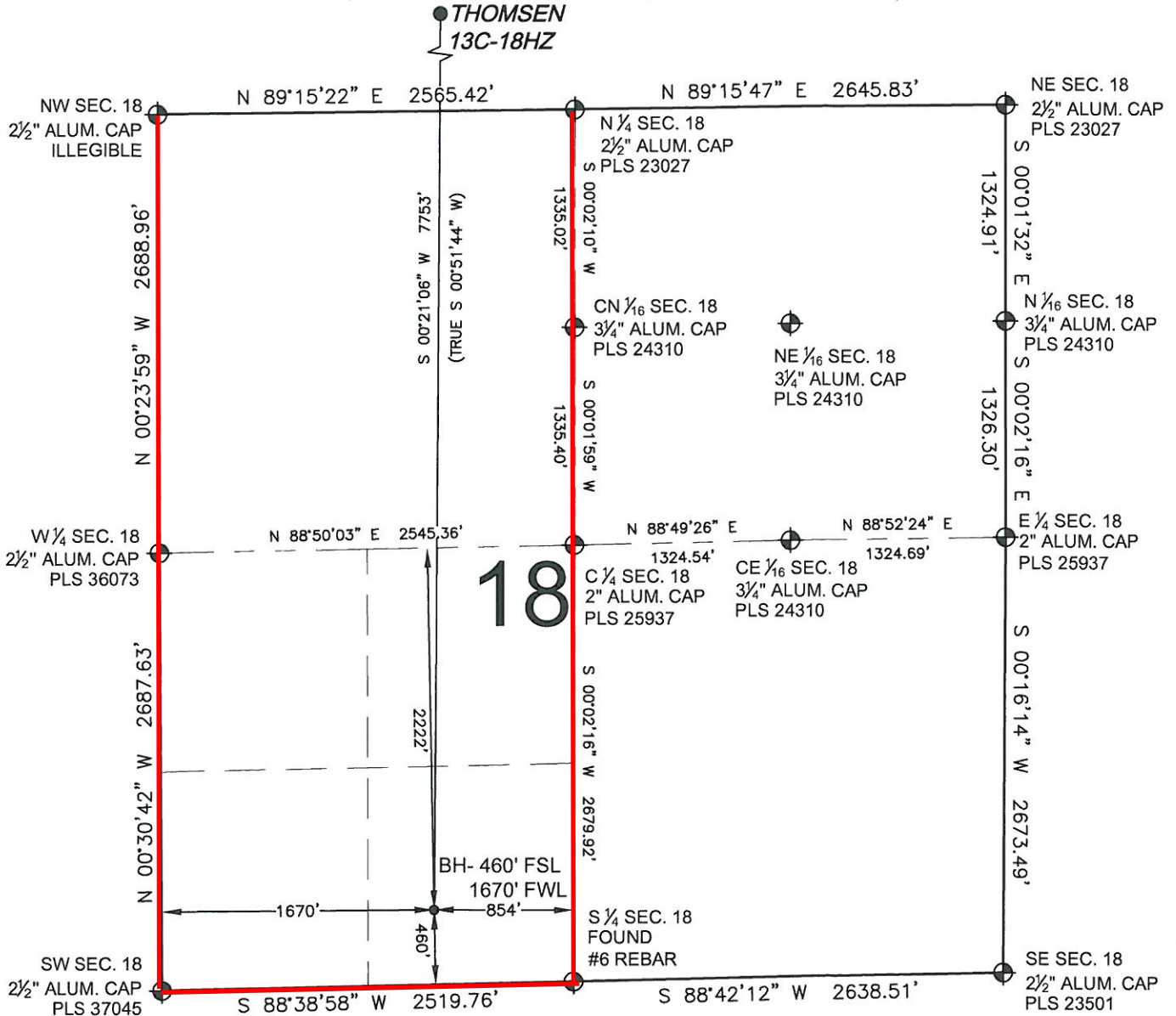

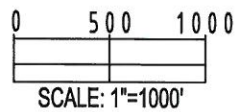
