I am reviewing the Form 2A location assessment for the HRM Resources Hiner Pad 41-26. Please address the following:

1. The interim reclamation date is only 5 days after the construction start date. Please provide revised dates for interim reclamation and construction (if necessary) to provide a more realistic timeframe between commencement of construction and interim reclamation.
2. It appears the nearest building is a livestock shed. I propose changing the distance to nearest building to 685 feet, which appears to be the building in the SE corner of the small neighborhood to the west on 25th Avenue. Let me know if you agree, or if there are closer buildings I am not aware of based on aerial photography, please identify them.
3. High Density Area: The location appears to be in a High Density Area because 18 or more building units are within the 1000 foot semi-circle west of the location. Please confirm the High Density Classification.
4. The nearest water well has been identified as 305 feet from the location (water well permit 43479-F). The Division of Water Resources records indicate that not only was this well mismapped, it has been abandoned. If a water well does exist 305 feet from the location, it should be included on the Location Drawing. Please provide a revised distance to the nearest water well, or revise the Location Drawing to show the water well location.
