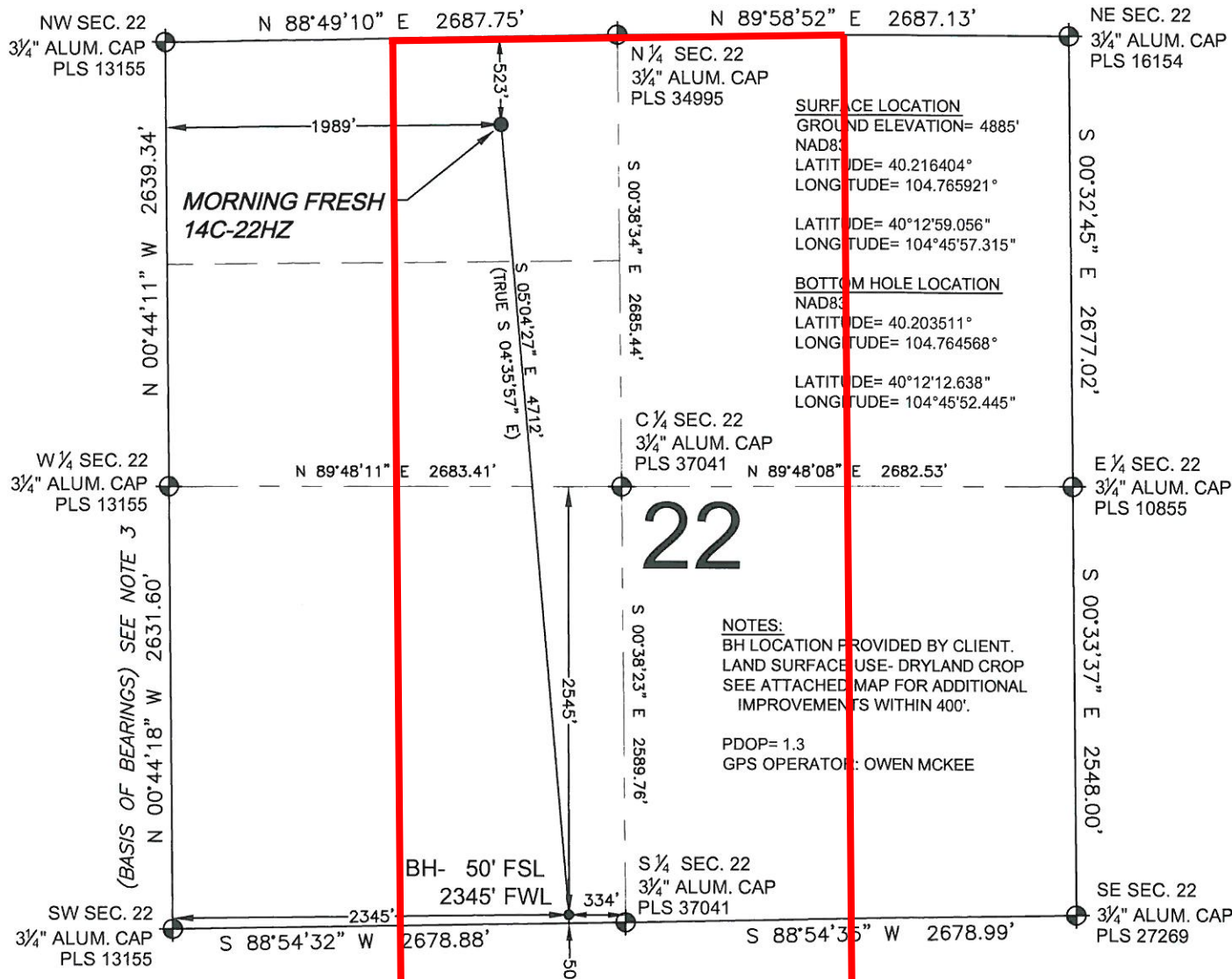

SECTION 22, TOWNSHIP 3 NORTH, RANGE 66 WEST, 6TH P.M.



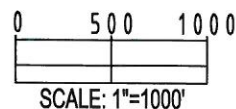
