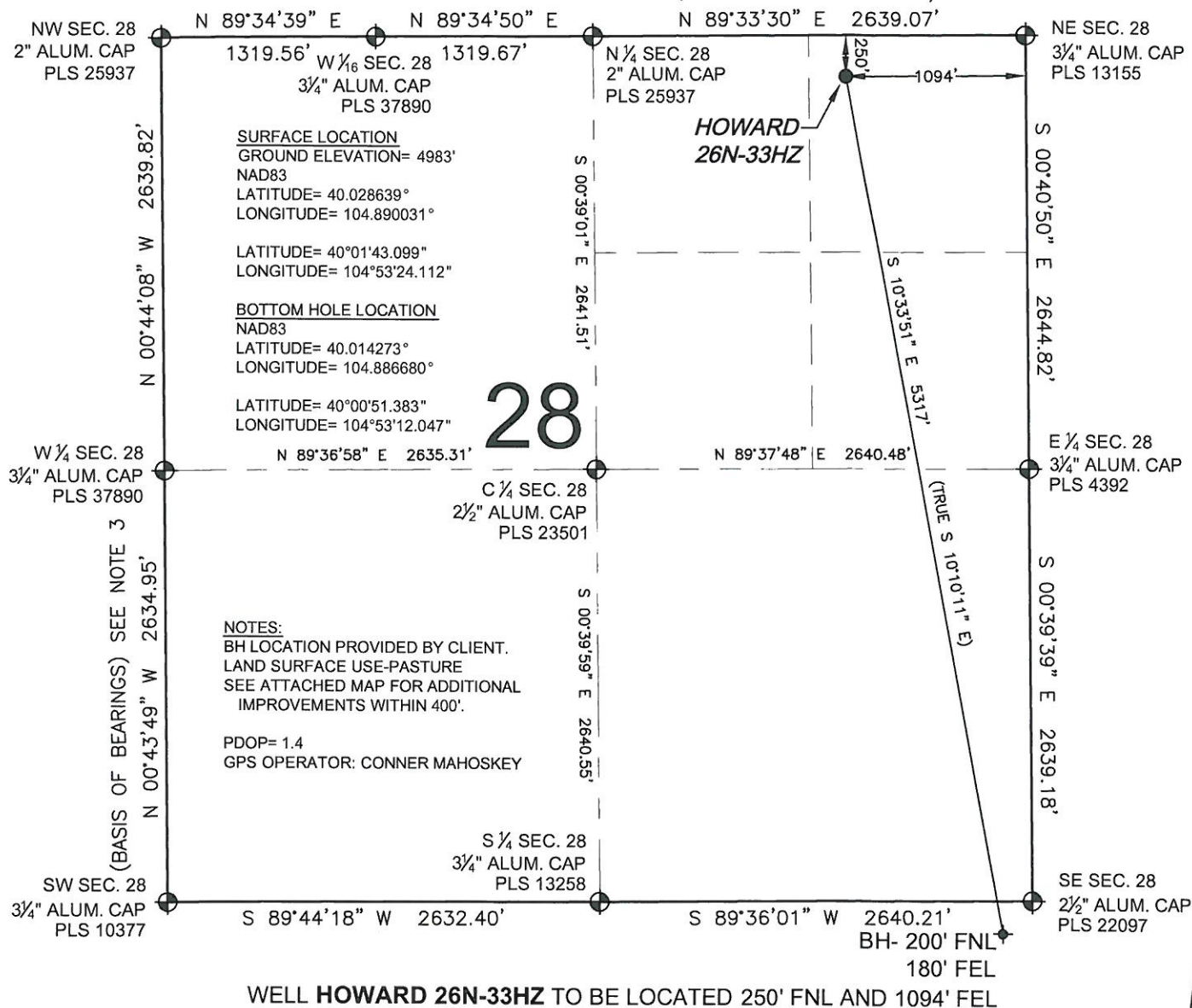


WELL LOCATION CERTIFICATE: HOWARD 26N-33HZ

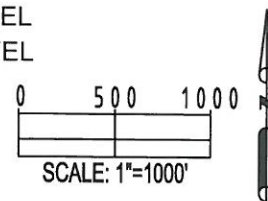
