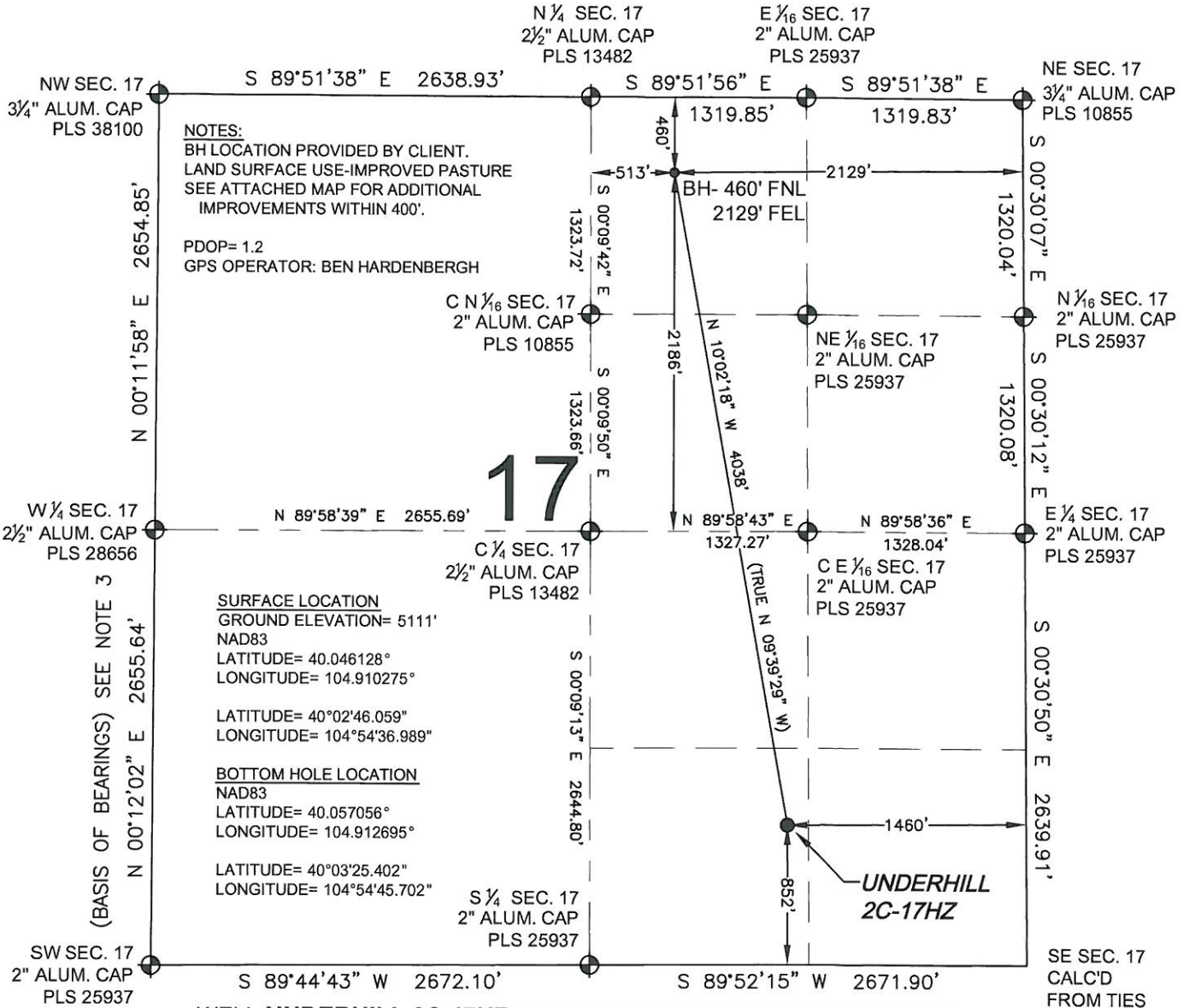


WELL LOCATION CERTIFICATE: UNDERHILL 2C-17HZ

- BH = BOTTOM HOLE

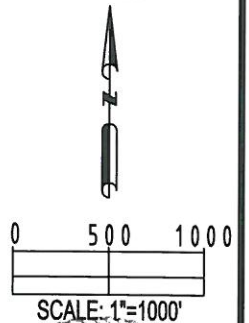
