### NOTICE OF HEARING BEFORE THE OIL AND GAS CONSERVATION COMMISSION OF THE STATE OF COLORADO CAUSE NO. 304

On February 17, 1978, the Commission issued its Order No. 304-1 which, among other things, established 320-acre drilling and spacing units for the production of gas from the Sussex formation underlying the following described lands in the Hambert Field, Weld County, Colorado, to-wit:

Section 7: All Section 19: All  
Section 18: All Section 30: All

Range 86 West, 8th P.M.  
Section 1: All Section 13: All

Section 11: All Section 24: All  
Section 12: All Section 25: All

It was further ordered that a hearing shall be held in six (6) months, at which time the Commission shall review data obtained from additional development in the spaced area in order to determine whether the spacing as established by Order No. 304-1 should be continued.

NOTICE IS HEREBY GIVEN, that the Oil and Gas Conservation Commission of the State of Colorado, pursuant to the above, has set the above-entitled matter for hearing on:

All owners and operators of leases in the Hambert Field are hereby requested to appear at the above-scheduled hearing and present information to the Commission in order to ascertain if the 320-acre spacing should be continued.

Pursuant to said hearing in the above-entitled matter, at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operation of said field, and to carry out the purposes of the statute.
