There will be no additional surface disturbances. The location does not require a variance from any of the rules listed in Rule 306.d.(1).(A).(ii). The location is not within a wildlife restricted surface occupancy area. Production will go to the existing McCarty 1 tank battery approx 1150 feet NW of the pad. My measurements for the railroad differ from the previous Form 2A based on data from the COGCC maps and distance to nearest surface water varied as well based on measurements from Google Earth and COGCC maps.
