This is a refile of Doc#1759820 approved on 1/13/2010 and expiring on 1/12/2013. I certify that there have been no changes on land use, lease description. The pad has been built. There will be no additional surface disturbances. The location does not require a variance from any of the rules listed in Rule 306.d.(1).(A).(ii). The location is not within a wildlife restricted surface occupancy area. Production will go to the existing Genesis 1 tank battery located approx 480 feet west of the pad, before Co Rd 29. Genesis 1 well is also on this pad. My measurements for nearest surface water and water well varied quite a bit from the previous Form 2A based on what I found on the COGCC website and Google Earth. I was unable to locate any surface closer than 764' and the closest completed water well was 617'.
