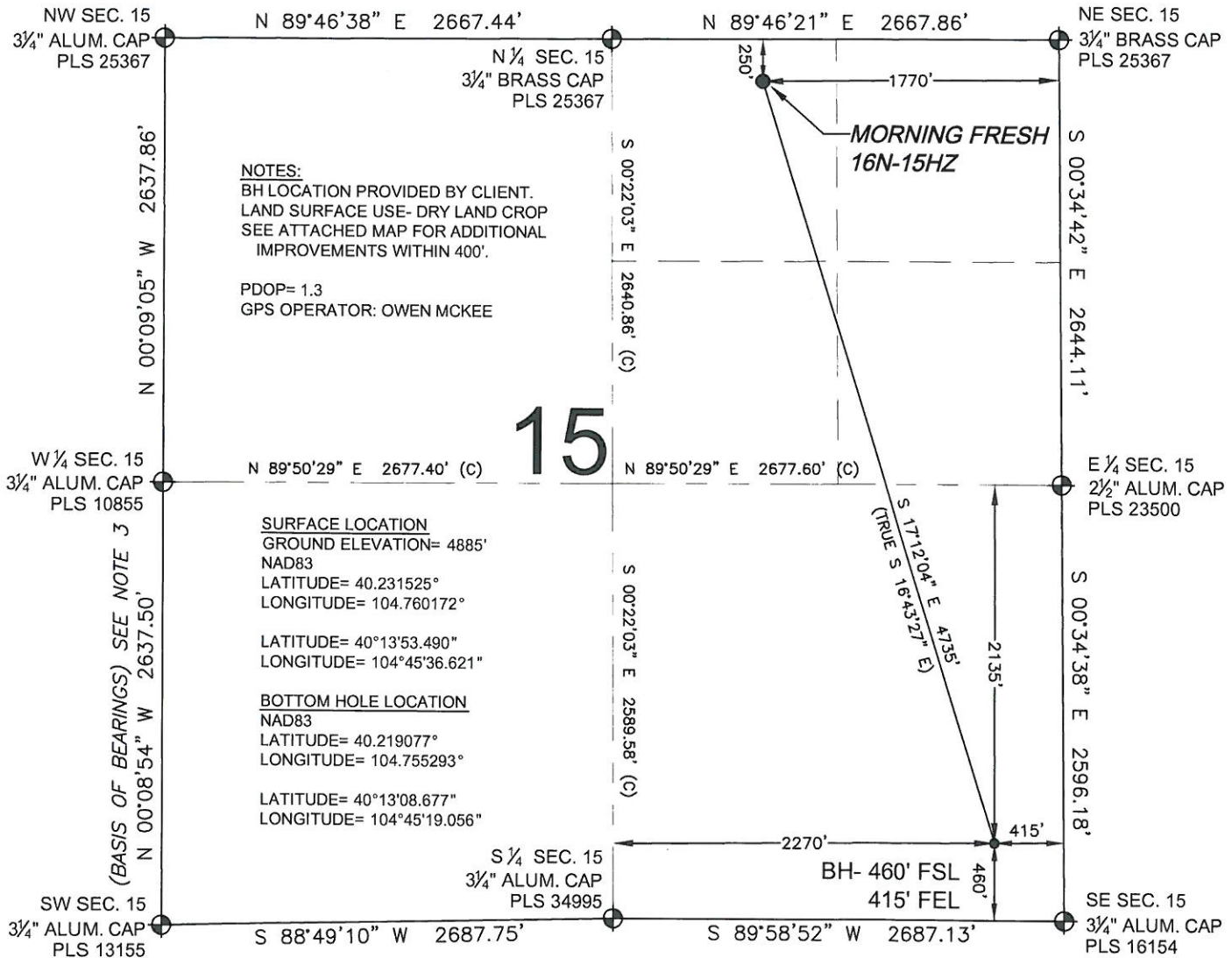


WELL LOCATION CERTIFICATE: MORNING FRESH 16N-15HZ

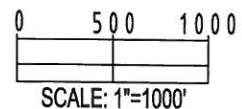
