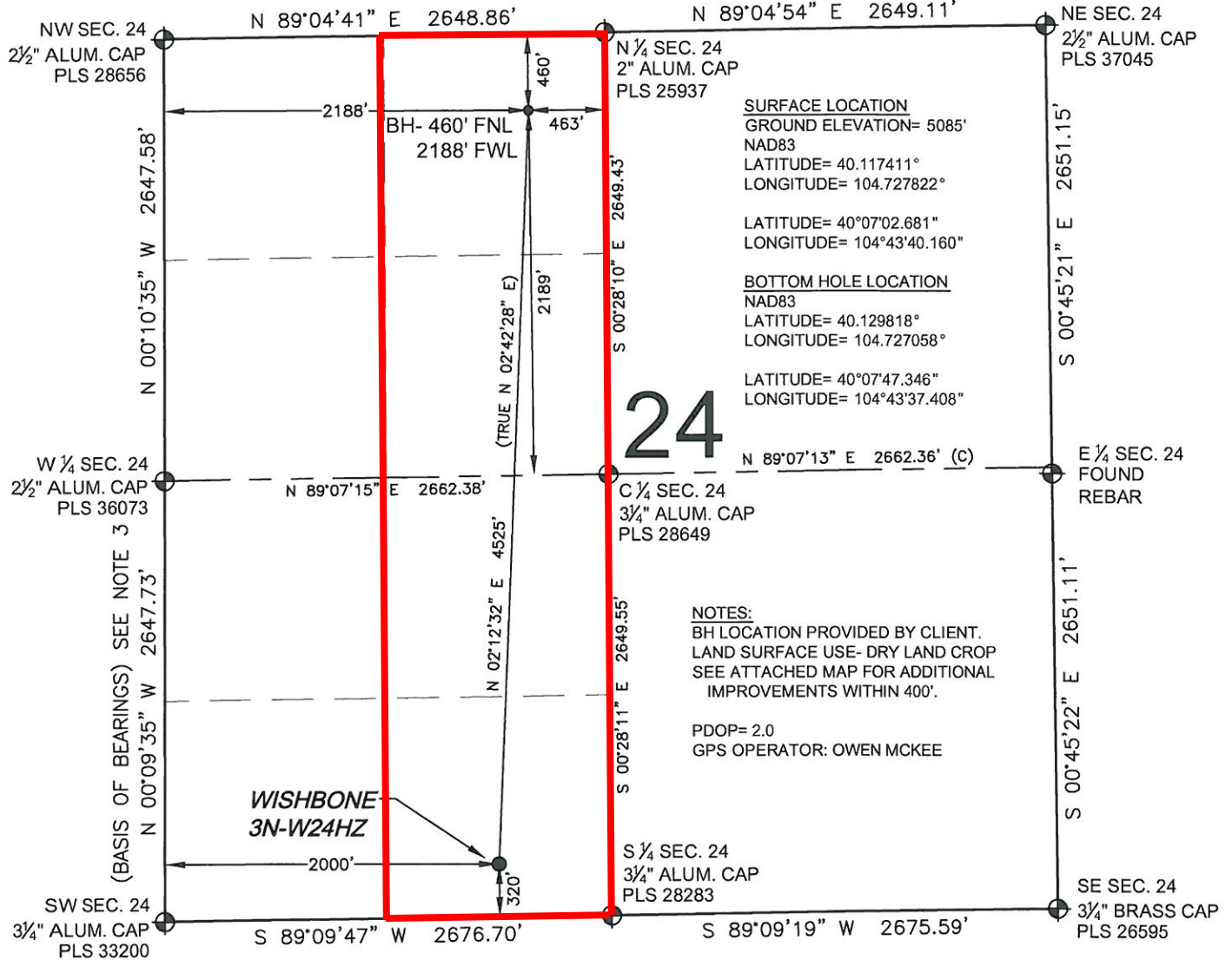

WELL LOCATION CERTIFICATE: WISHBONE 3N-W24HZ

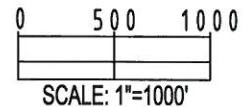
