The Federal 299-23-2 well is on the Idle wells list. Based on results from the nearby Federal 299-27-5 and 299-27-6, WPX Energy believes this well is a good candidate for conversion to injection / Salt Water Disposal in the upper Mesaverde group (Ohio Creek and Upper Williams Fork). WPX Energy is continuously evaluating this well for conversion potential.

Upon conclusion of the evaluation process, a full UIC permit will be sent to the COGCC for approval as a Salt Water Disposal Well. At this time, an additional Sundry Notice will be submitted to the BLM with recompleat and conversion procedures for review and approval and A Sundry Notice will also be sent to the Natural Resource Specialist for review under the NEPA process.
