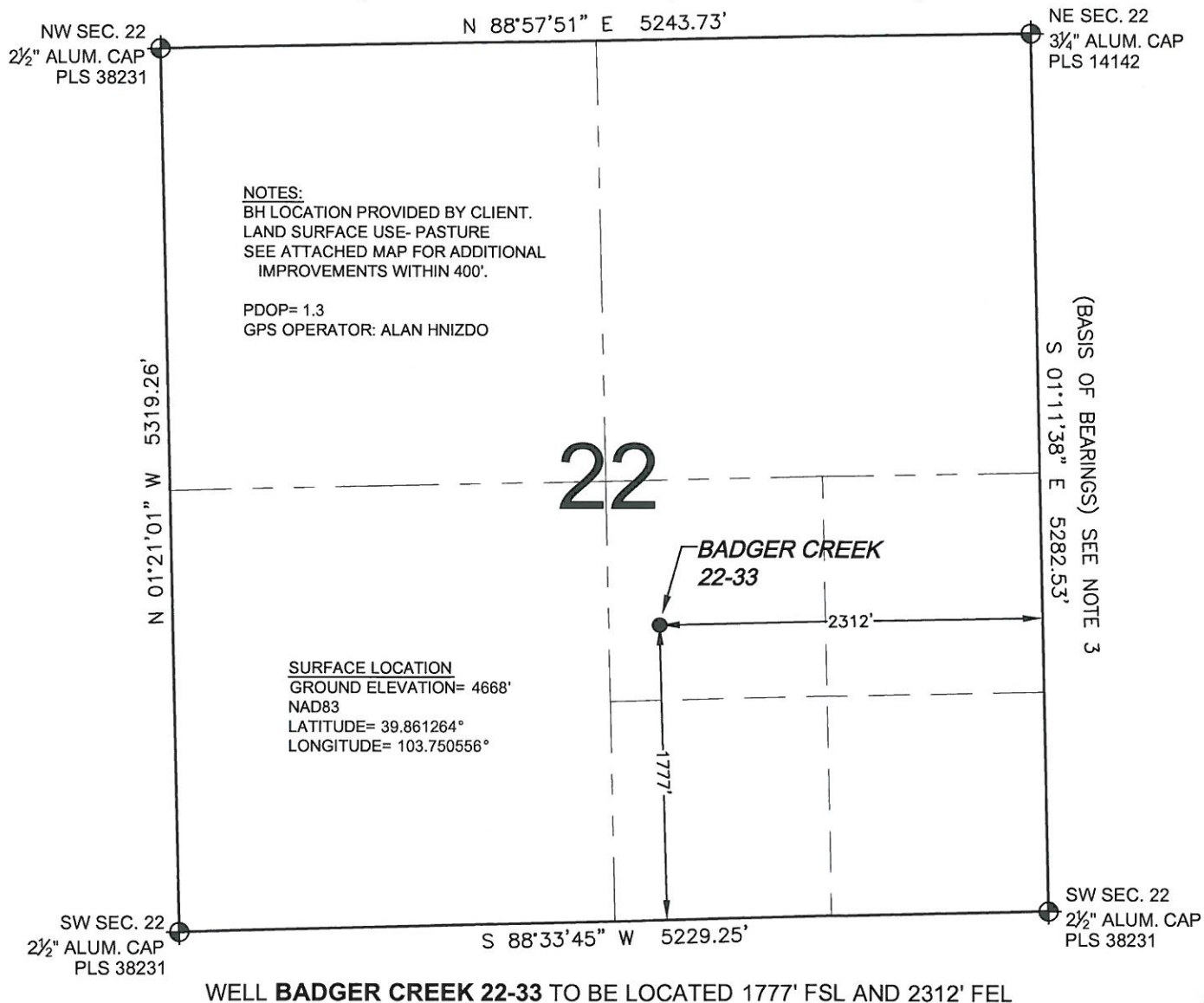


WELL LOCATION CERTIFICATE: BADGER CREEK 22-33

LEGEND

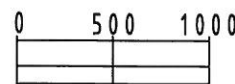
- ⊕ = EXISTING MONUMENT ⊕ = BOTTOM HOLE
