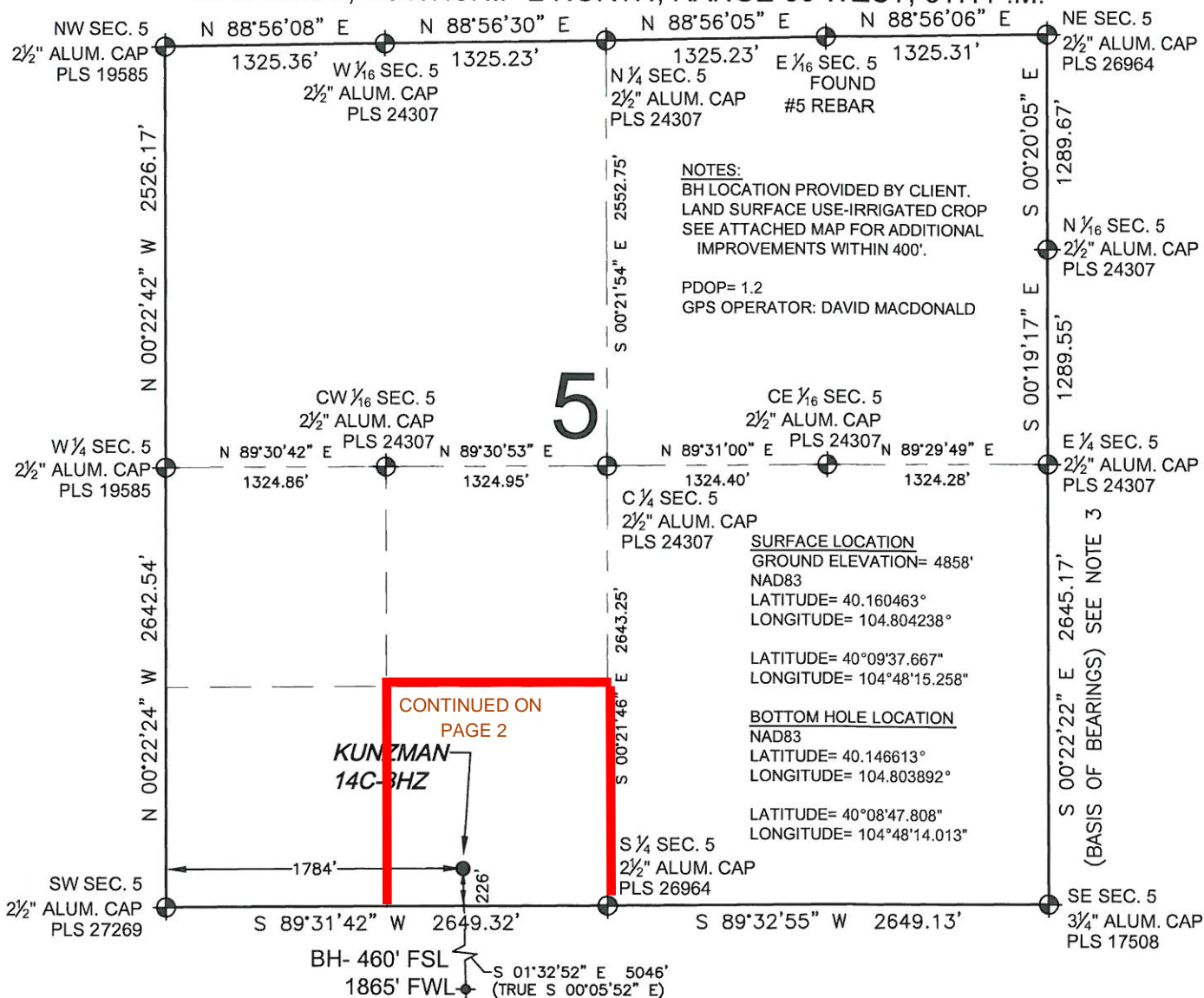

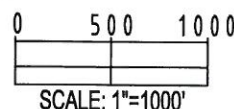

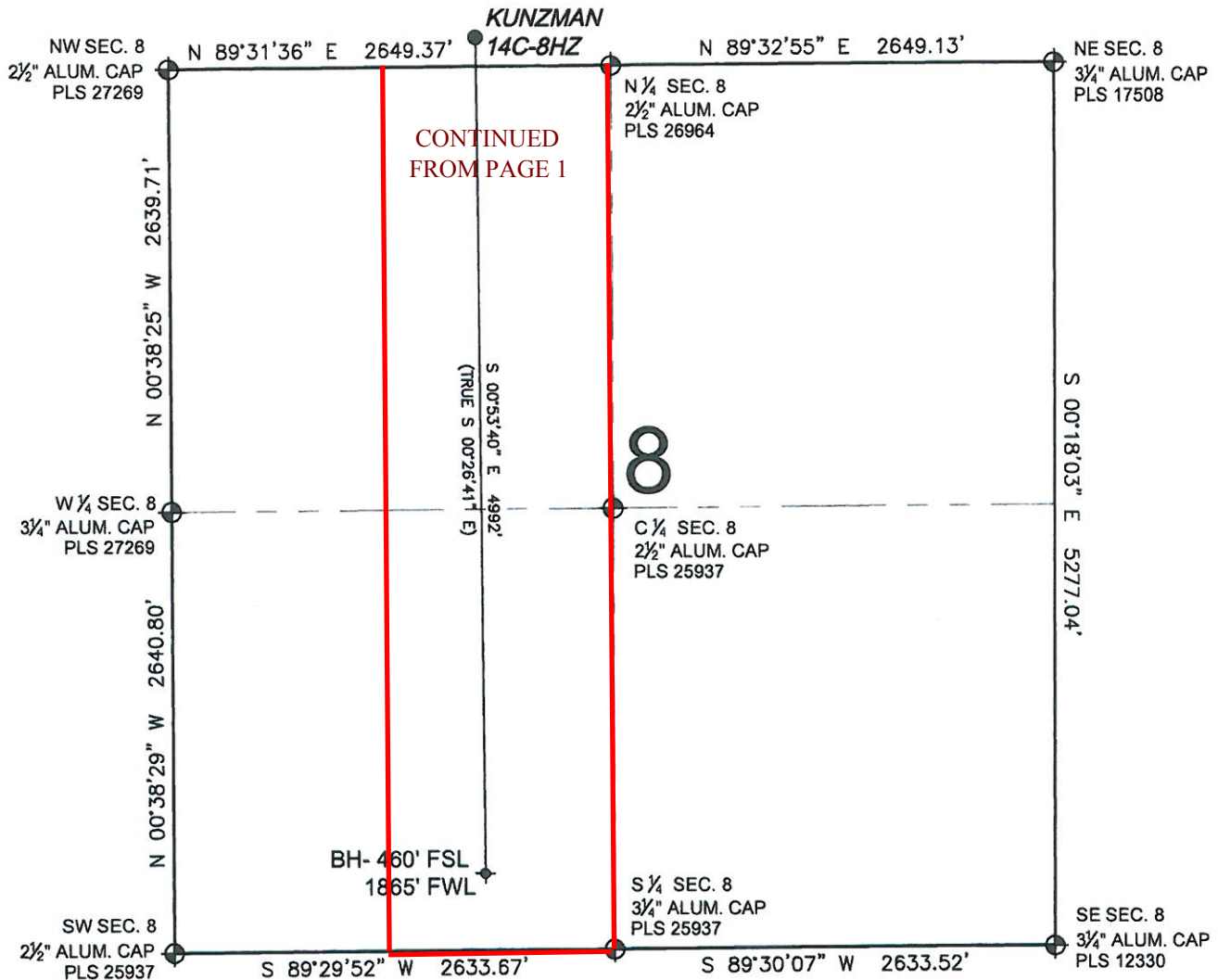

WELL LOCATION CERTIFICATE: KUNZMAN 14C-8HZ



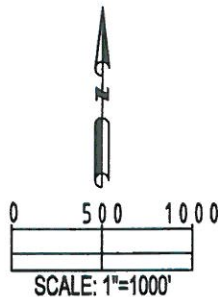
