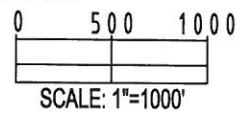

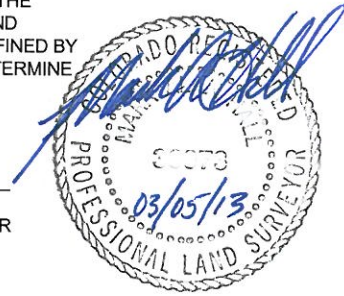

WELL LOCATION CERTIFICATE: KUNZMAN FEDERAL 13C-8HZ



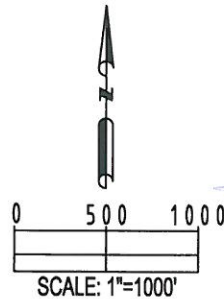
