**NOTICE OF HEARING

IN THE MATTER OF THE INVESTIGATION TO TAKE MEASURES TO PREVENT WASTE OF OIL AND GAS IN THE DIVIDE AND MINTO-WEST FIELDS, LOGAN COUNTY, COLORADO.
TO ALL INTERESTED PERSONS AND TO WHOM IT MAY CONCERN:**

On January 12, 1960, the Shell Oil Company filed with the Commission an application for an order amending Order No. 61-1, by deleting the "D" sand and leaving only the "J" sand in Cause No. 61, Minto-West, leaving the area as defined in said Order No. 61-1; and amending Order No. 38-1 to redefine the Divide Field by deleting portions of the area and including part of the "D" sand reservoir now underlying the Minto-West Field, as defined in said Order No. 61-1, and additional lands outside the present limits of the Divide Field by extending the area defined in said Orders No. 38-1 and 61-1, by the addition of the following lands in Logan County, Colorado, to-wit:

Township 8 North, Range 53 West, 6th P.M.
Section 4: Lot 1, SE $\frac{1}{4}$ NE $\frac{1}{4}$
Section 9: SE $\frac{1}{4}$, N $\frac{1}{2}$ SW $\frac{1}{4}$
Section 10: SW $\frac{1}{4}$, N $\frac{1}{2}$ SE $\frac{1}{4}$, SW $\frac{1}{4}$ SE $\frac{1}{4}$

to make the limits of the Divide Field, "D" Sand, as follows:

Applicant also requests an order approving a certain Unit Agreement and water flood operations in the "D" sand of the Unit Area as presented by Applicant in said Unit Agreement, and defined as follows, to-wit:

Pursuant to said hearing in the above entitled matter, at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operation of said field, and to carry out the purposes of the statute.

All interested persons are invited to appear and be heard on the above date.
