5. DESCRIBE PROPOSED OR COMPLETED OPERATIONS

Encana Oil & Gas (USA) Inc. requests permission to change surface and production casing programs for the above referenced well.

Will be a tapered hole. Conductor casing will change from 0-40' with a 24" hole and 20" casing size to 0-60', with a 24" hole and 16" casing size. Surface casing will go from 0-200' with a hole size of 14-3/4" and casing size of 9-5/8". Surface casing will continue from 200'-976' with a hole size of 12-1/4" and casing size of 9-5/8" Cement volume for surface casing will increase from 354 sk to 383 sk. Production casing will change from 0-8164' with a hole size of 7-7/8" and casing size of 4-1/2" to a tapered plan: from 0-6022' with a hole size of 8-3/4" and casing size of 4-1/2". And continue on from 6022'- 8118' with a hole size of 7-7/8" and casing size of 4-1/2", thus decreasing the TD from 8164' to 8118' Production cement will increase from 526 to 546 sk
