BEFORE THE OIL AND GAS CONSERVATION COMMISSION OF THE STATE OF COLORADO IN THE MATTER OF THE PROMULGATION OF FIELD RULES TO GOVERN OPERATIONS) CAUSE NO. 26 IN THE "D" SAND OF THE ADENA FIELD, MORGAN COUNTY, COLORADO

NOTICE OF HEARING TO ALL INTERESTED PERSONS AND TO WHOM IT MAY CONCERN: On November 26, 1957, The Pure Oil Company filed with the Commission an application for an order amending the provisions of Rule 2 of Order No. 26-32 dated November 28, 1956, and Rule 2 of Order No. 26-25 dated October 28, 1955, and any other orders issued by the Commission pertaining to limitation of gas production in the "D" sand of the Adena field, so as to provide that the allowable for production of gas from gas wells in the Adena "D" Sand Field, be established on the basis of two six-months periods each year, with appropriate provision to allow production of larger quantities of gas during the periods of greater efficiency, and compensating production of lesser quantities during the periods of lesser efficiency.
