

NOTICE OF CONTINUATION OF HEARING
CAUSE NO. 26
BEFORE THE OIL AND GAS CONSERVATION COMMISSION OF THE STATE OF COLORADO
IN THE MATTER OF THE PROMULGATION OF FIELD RULES TO GOVERN OPERATIONS IN THE SAND OF THE ADENA FIELD, MORGAN COUNTY, COLORADO
TO ALL INTERESTED PERSONS AND TO WHOM IT MAY CONCERN:
On June 19, 1958 the Commission issued its Order No. 26-40 which, in Rule 2, provided in part that income derived from the allowable production obtained from the Delaney No. 1 and No. 2 wells located in Section 26, Township 1 North, Range 58 West, Morgan County, Colorado, shall be combined to pay-out the Delaney No. 2 well; and in Finding 8 thereof, stipulated that the Commission should hold a hearing at the approximate time of such pay-out to accept and review additional pertinent information for determination of an allocation for Tract 81-B.
NOTICE IS HEREBY GIVEN, that The Oil and Gas Conservation Commission of the State of Colorado, pursuant to said Order No. 26-40, originally set the above entitled matter for hearing on February 17, 1959, and has now continued said hearing to:
