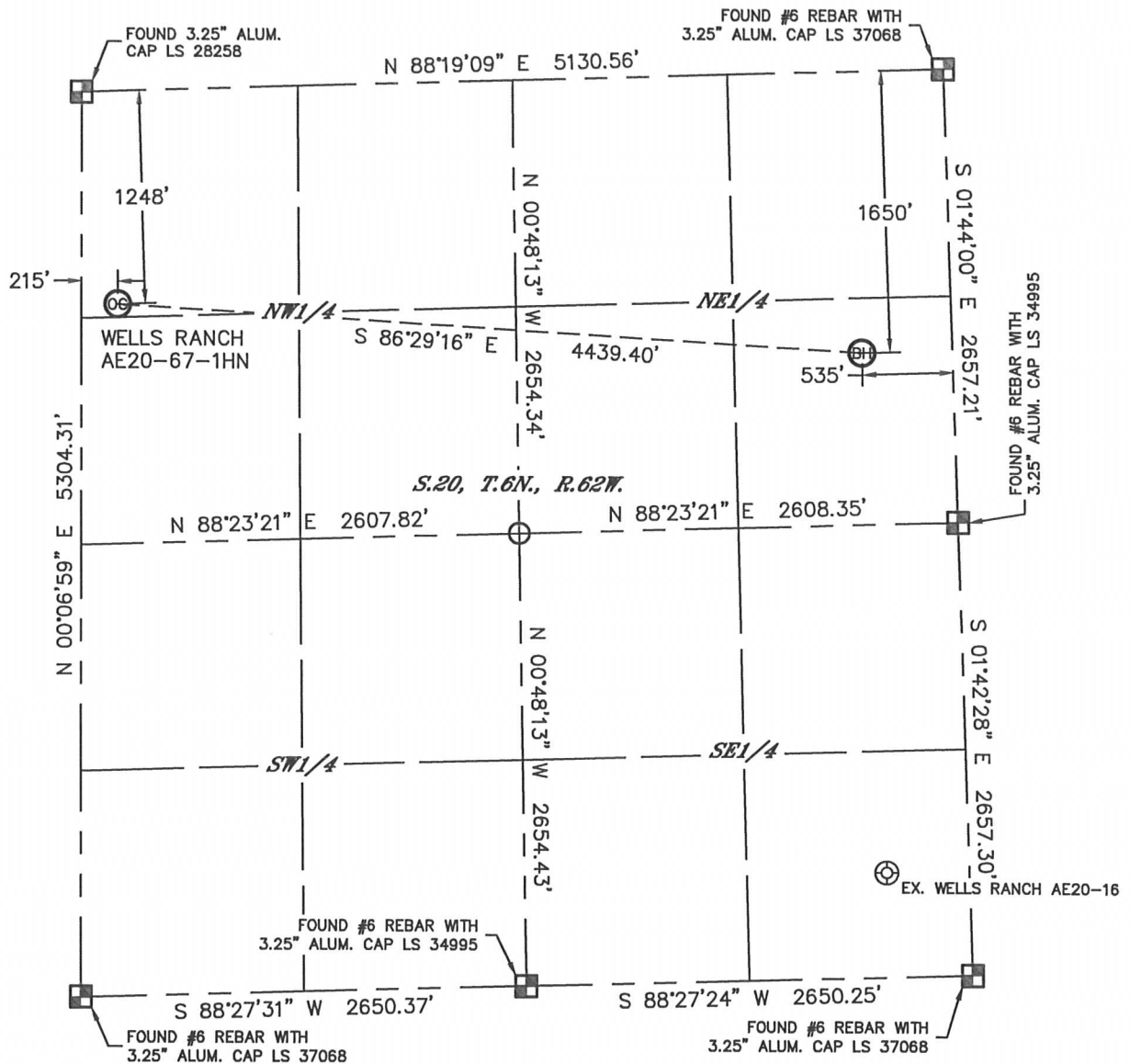

In accordance with a request from Brian James with Noble Energy Inc., Lat40°, Inc. has determined the surface location of the WELLS RANCH AE20-67-1HN to be 1248' from the NORTH line and 215' from the WEST line and the bottom hole to be 1650' from the NORTH line and 535' from the EAST line as measured at right angles from the section lines of Section 20, Township 6 North, Range 62 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 11/01/2012, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.

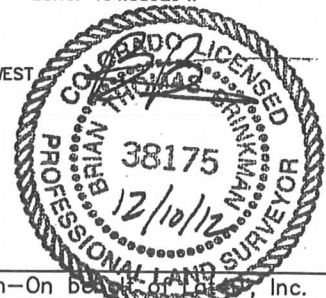

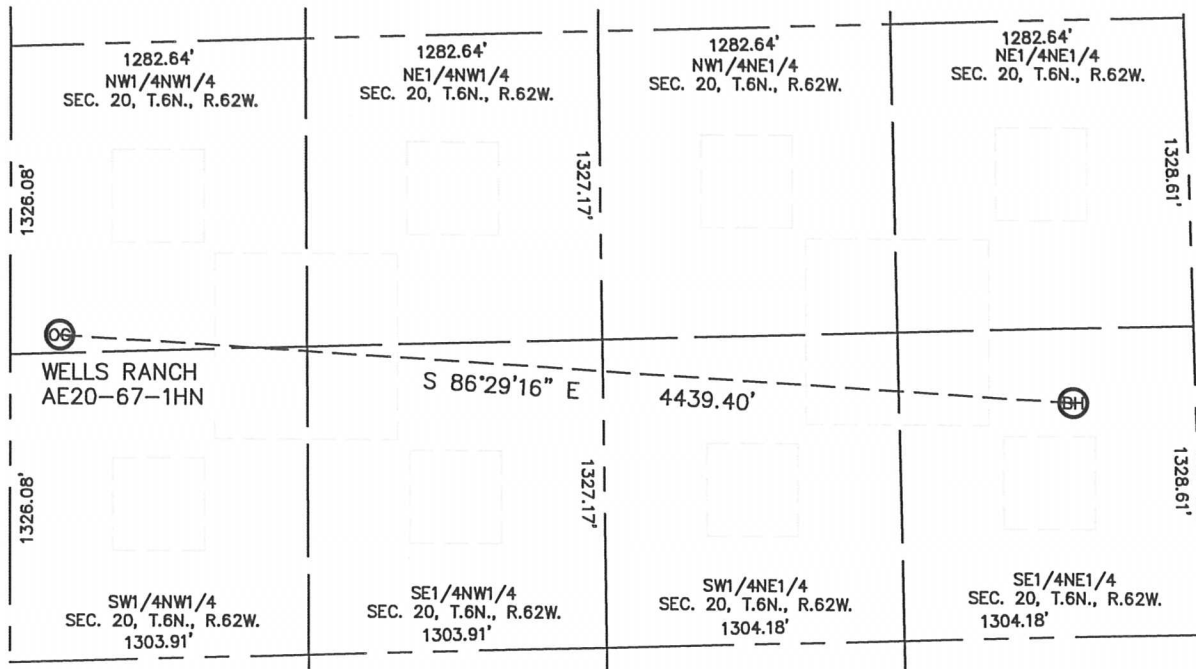

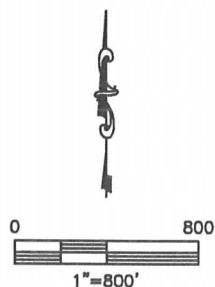
# SITE SKETCH
