Attached please find the final groundwater report and supporting documentation for the above

referenced subject site. Soils and groundwater were impacted from a dump line release. Impacted soils were excavated and transported to a permitted facility for disposal. Groundwater monitoring wells were installed and PDC has been completing quarterly groundwater sampling since the release was discovered. Following the most recent sampling event on December 20, 2012, laboratory analytical results confirmed BTEX concentrations in groundwater have been in compliance with COGCC Table 910-1 groundwater standards for four consecutive quarters. Based on this, PDC is requesting a No Further Action determination from the COGCC.
