The Commission has previously issued orders establishing drilling and spacing units and defining field limits for the Badger Creek Field, Cause No. 21, and the Little Beaver Field, Causes No. 15 and No. 30.

On April 2, 1962, the Monsanto Chemical Company filed with the Commission an application for an order:

1. Deleting the W 1/2, SE 1/4, S 1/2 NE 1/4, and NW 1/4 NE 1/4 of Section 1, and all of Section 12, Township 2 South, Range 57 West of the 6th P.M., from the Little Beaver Field.
2. Deleting the S 1/2 of Section 13 and the E 1/2 NE 1/4 of Section 1, Township 2 South, Range 57 West of the 6th P.M., from the Badger Creek Field.
3. Confirming the location of the No. 2 Scripsmier in the SW 1/4 SE 1/4 SW 1/4 of Section 1, Township 2 South, Range 57 West of the 6th P.M., as a permitted exception to Rule 317 of the Commission.
