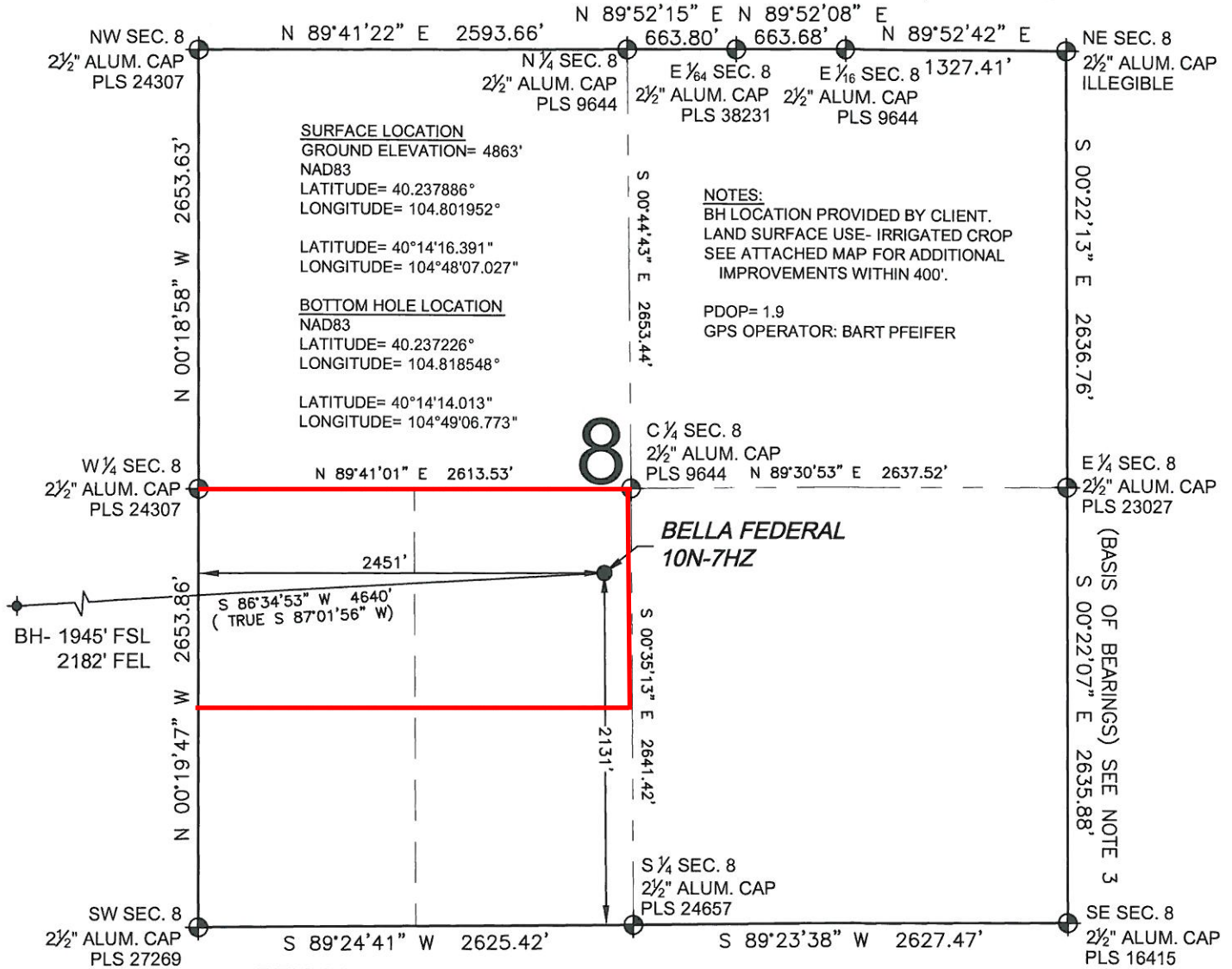

WELL LOCATION CERTIFICATE: BELLA FEDERAL 10N-7HZ

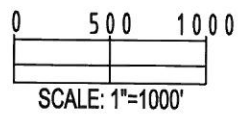

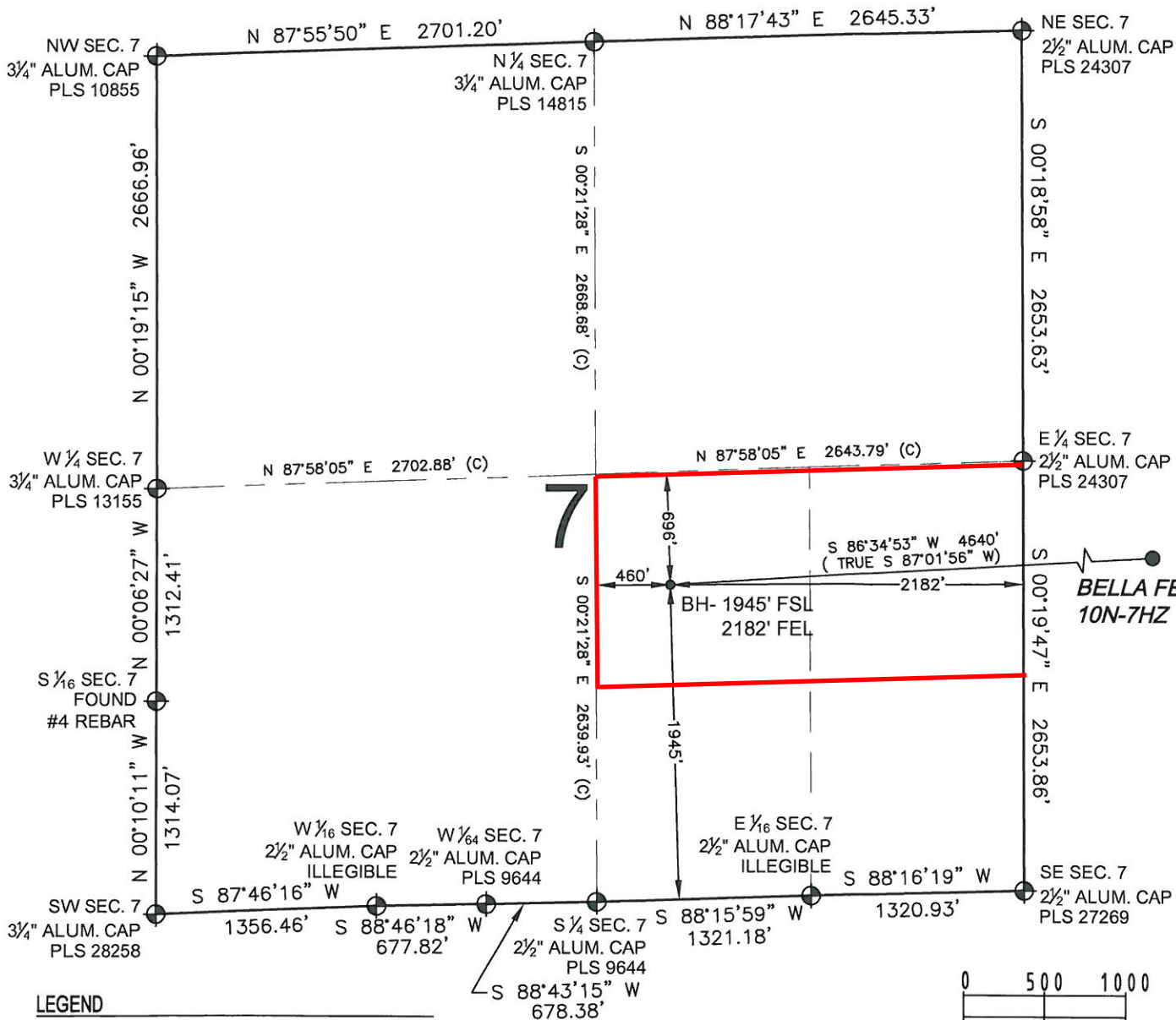
