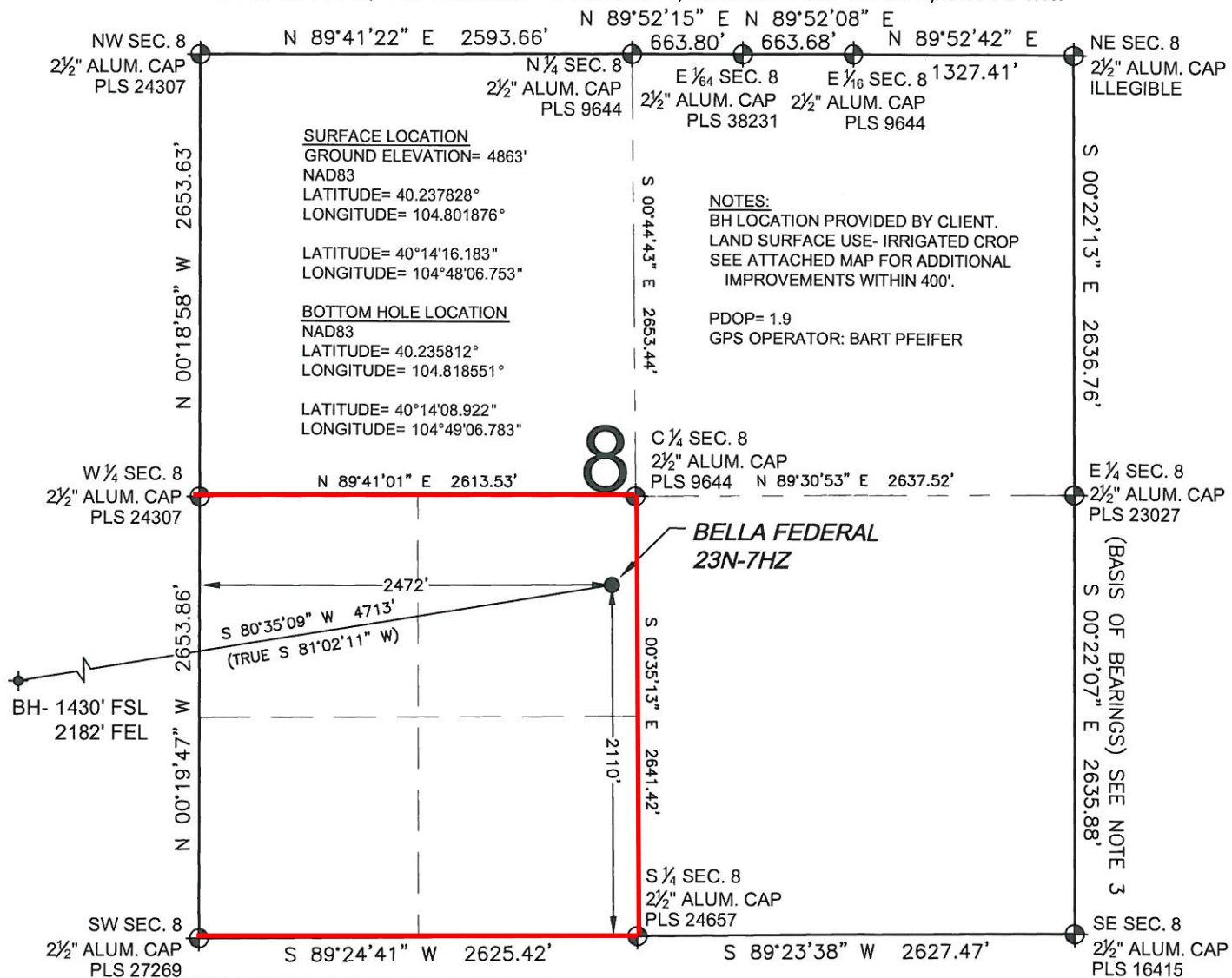

WELL LOCATION CERTIFICATE: BELLA FEDERAL 23N-7HZ

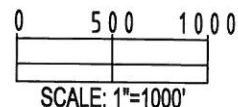

● = PROPOSED WELL ♦ = EXISTING WELL

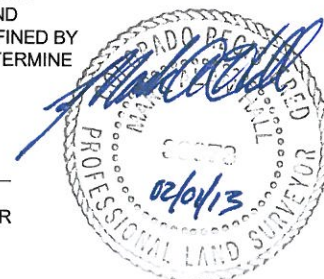

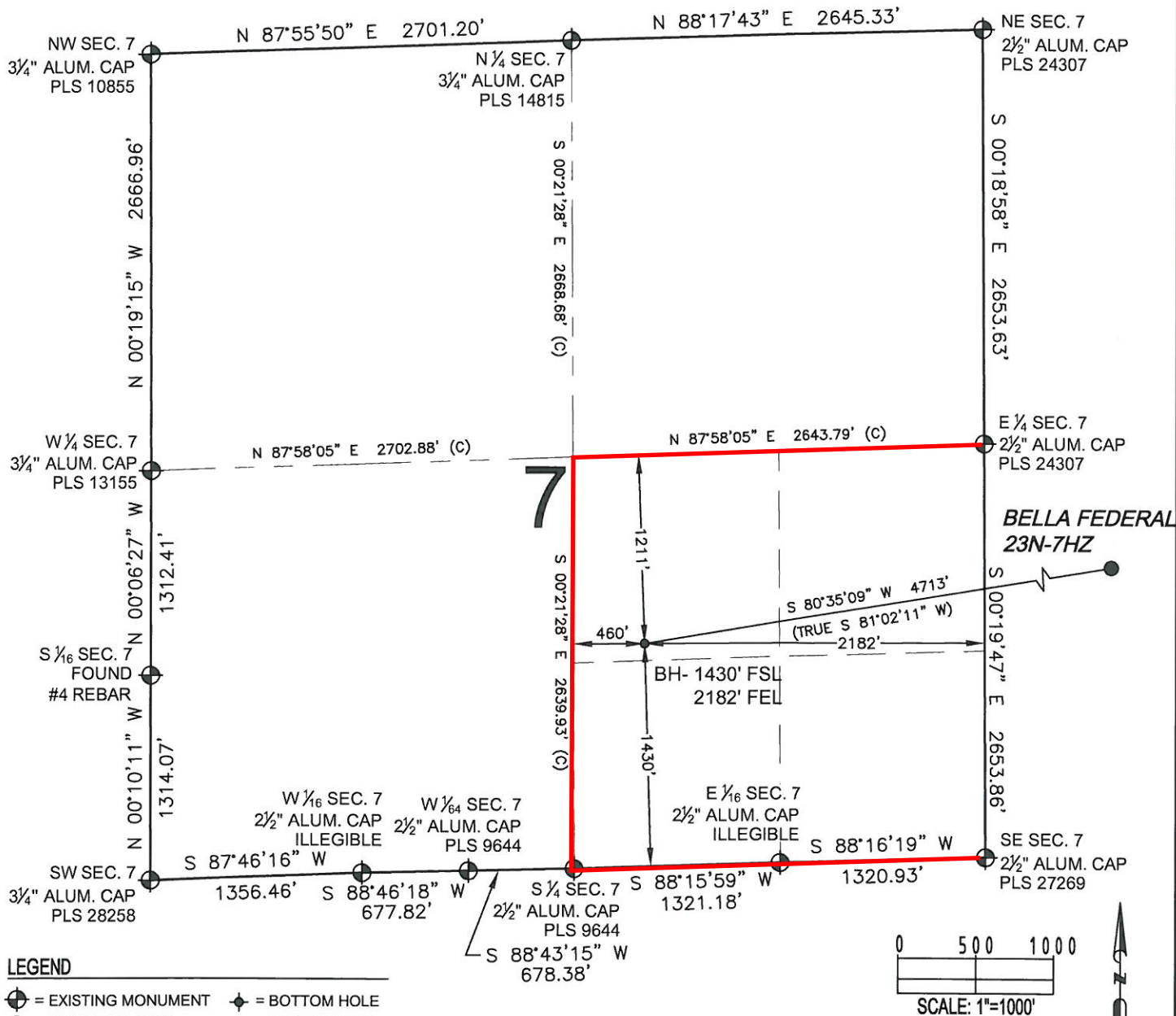
