Comment: Inspection performed July 2010 (doc#200262935) stated "STABILIZE AND RESTORE CUT SLOPE" and "LOCATION REQUIRES INTERIM RECLAMATION". This has not been performed. A slope failure occurred on the cut slope approximately 20 feet wide. Tension cracks are present in the near vertical slopes adjacent to the slope failure. Additional slope failure is likely without stabilization.

CA: Perform adequate interim reclamation and provide a schedule for the planned work on a Form 42.
