Liz,

I need some additional information regarding the PDC Alm 33V-HZ South and North well pads.

How will the facilities for each of these locations be placed? Do you have additional drawings showing the facility locations?

A large number of facilities (32 oil tanks) are proposed for the north pad, and I am not convinced these facilities can be accommodated on 1.5 acres. A smaller number of facilities are proposed for the south pad. Why is this different?

Additional drawings showing the locations of the wells and production facilities are needed to determine whether we need 1, 2 or 3 Form 2As to account for the planned operations.
