### 15. Comments:

The closest water well to location is permit #:262798- - located 290' FSL, 415' FWL (SWSW) Sec. 32 6N 67W, approximately 1490' from the location. This well is designated for household use only, and while it does have a report that a pump was installed in 06/2005 there is no record of its first beneficial use, nor that it was actually pumped. Pump depth is reported as 200'. Static water level was determined from water well permit #: 63272- - located 1820' FNL, 1336' FEL (SWNE) Sect. 32 6N 67W, approximately 4084' from location. This well pumped @ 1 gpm with a static water level of 63'. There is no elevation listed for this well, but topographic maps show it as approximately 85' below location. Correcting for this difference results in an estimate of 148' to groundwater at location. Operator requests a Rule 318A(a) and 318A(c) exception location; well is to be located outside of a GWA drilling window and will be located more than 50' from an existing location. Request and waiver are attached.
