ELM RIDGE EXPLORATION CO LLC SPUD THE ABOVE REFERENCED WELL ON APRIL 25, 2013. WE DRILLED A 12 1/4" HOLE TO 354' AND ON APRIL 26, 2013 AND RAN JOINTS 8 OF 8 5/8" 24# J-55 CASING TO 346'. PUMPED 54 SACKS OF CEMENT WITH 20 BBLS EXCESS CEMENT TO SURFACE. WE PRESSURE TESTED WELL TO 600 PSI FOR 30 PLUS MINUTES, TEST WAS GOOD. JOB WAS NOT WITNESSED BY THE COGCC.
