Details of work:

Control well w/ 2% KCL. RIH w/ blade bit, and scraper, 233jts. Tagged fill at 7300' KB. Roll hole clean. TIH w/ RBP, retrieved head, 221 jts 2 3/8" tubing. Set RBP @ 6952' KB w/ 221 jts. Pressure test to 1000#. Spot 2sks sand on plug. Unland casing. Pick Up mule shoe and TIH w/151 jts of 1 1/4" to 4764'. Test lines to 3500 psi. Pump 10 bbls ahead. Pump 300 sks of 50/50 POZ @ 13.5 ppg cement from 4782' to 4660'. Pump 330 sks of "G" neat 15.8 ppg cement from 695' to surface. Bond log from 5000' to surface. There is cement from 4770' to 2400' and from 670' to surface. RIH w/ retrieving head and establish circulation and latch onto RBP. Roll hole clean and release RBP. Land 1 1/4" 2.33 # J-55 tubing to 7071.29' KB. Rig down and move off.
