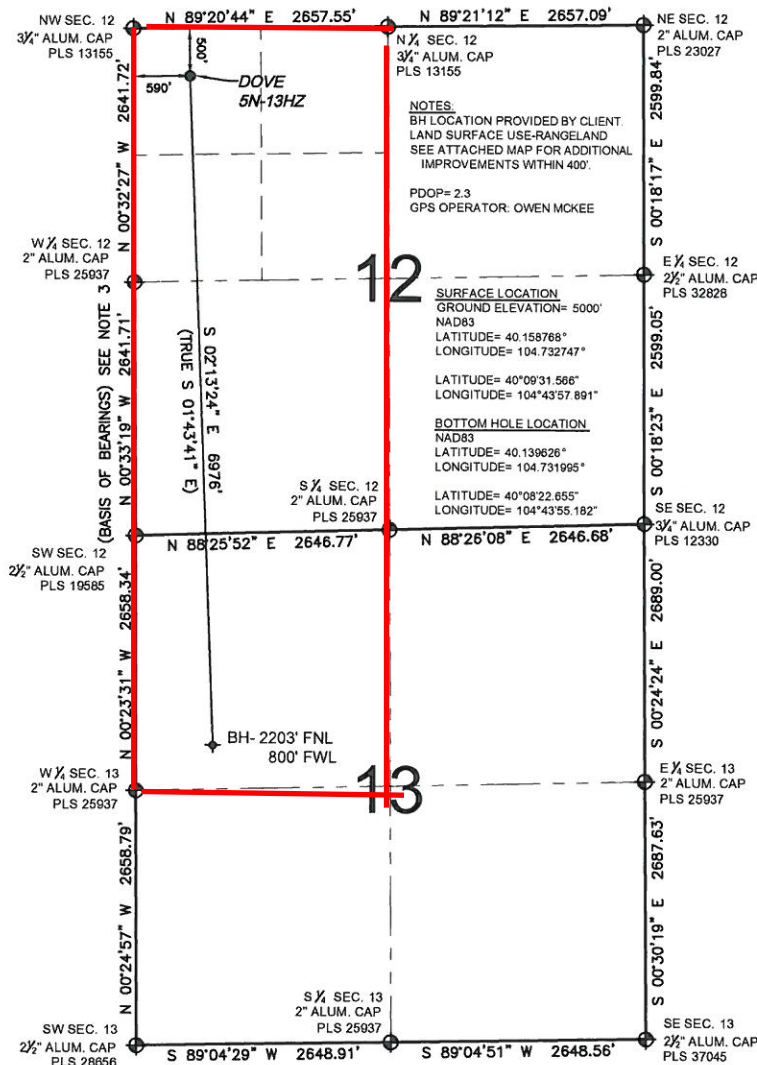

## WELL LOCATION CERTIFICATE: DOVE 5N-13HZ

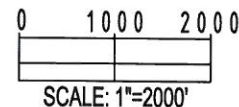

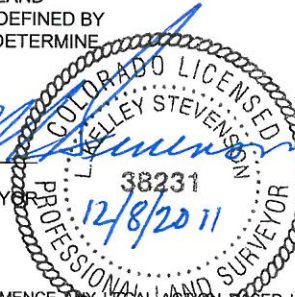
