Details of work:

Control well w/ 2% KCL water. RIH w/ blade bit, and scraper, 242jts. Tagged fill at 7760' KB. TIH w/ RBP, retrieved head, 227 jts 2 3/8" tubing. Set RBP @ 7171' KB w/ 227 jts. Roll hole clean. Pressure test to 1500#. Spot 2 sks sand on plug. Unland casing. Pick Up mule shoe and TIH w/33 jts of 1 1/4" to 1026'. Test Iron to 3000 psi. Pump 5 bbls ahead. Pump 171 sks of "G" neat 15.8 ppg cement from 1540' to 715'. Reland casing. Bond log from 1550' to surface. Annular fill cement goes from 1540' to 715'. RIH w/ retrieving head and establish circulation and latch onto RBP. Roll hole clean and release RBP. Land 2 3/8" 4.7 # J-55 tubing to 7651.52' KB. Rig down and move off.
