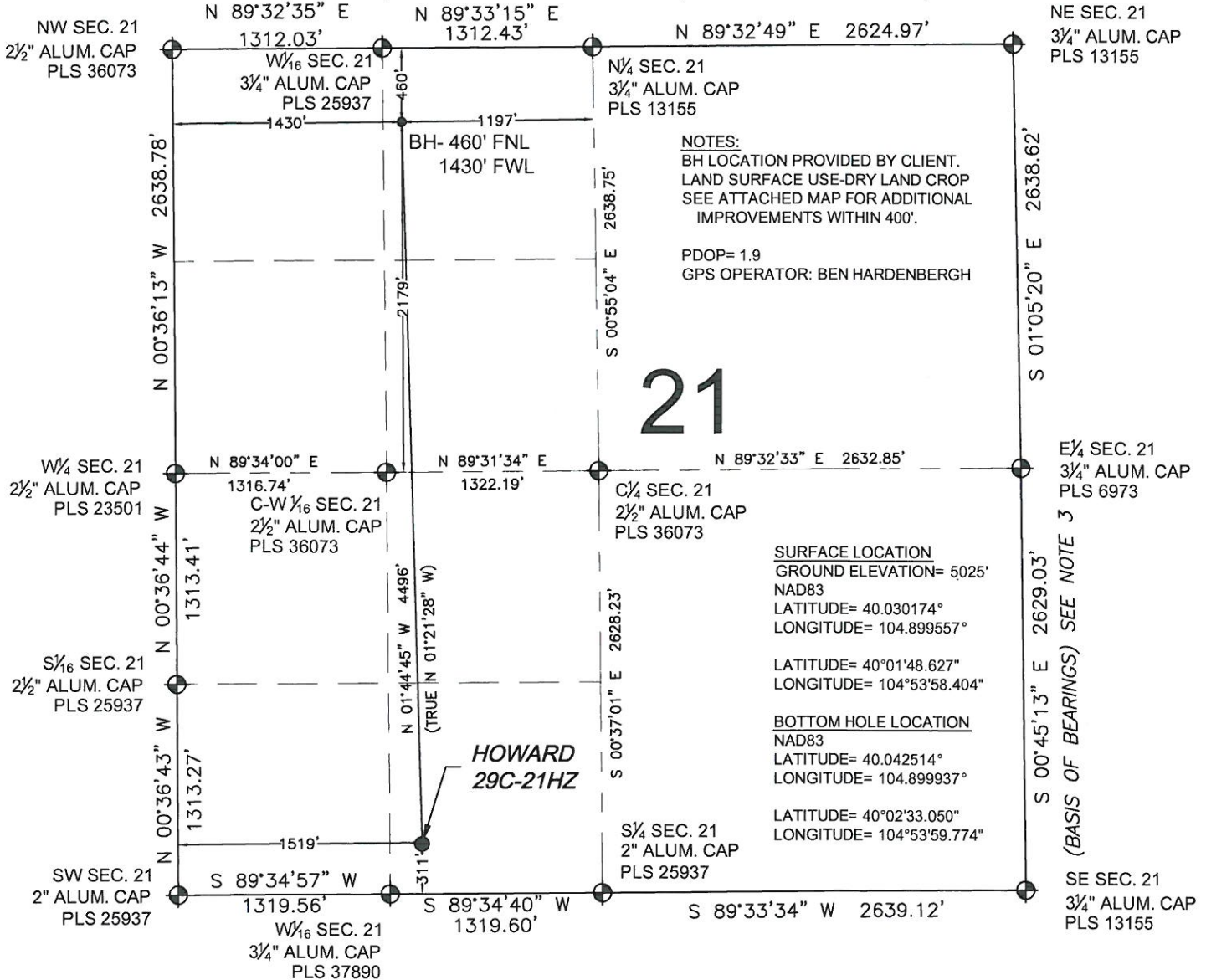


# WELL LOCATION CERTIFICATE: HOWARD 29C-21HZ
