THIS WELL IS PART OF THE CBM PA IN EAST MAMM AND WAS ORIGINALLY SHUT IN DUE TO HIGH WATER PRODUCTION AND A LACK OF WATER DISPOSAL. THE WELL WAS TEMPORARILY ABANDONED ON 10-24-11 WITH A RBP @ 4060' IN ORDER TO RUN A MECHANICAL INTEGRITY TEST. AS THERE WERE NO IMMEDIATE PLANS TO RETURN THE WELL TO PRODUCTION, THE RBP WAS LEFT IN THE WELLBORE. THIS WELL PASSED THE MIT ON 11-10-11 AND IS EXPECTED TO REMAIN IN TA STATUS UNTIL 2016.
